Applicable to All students:

- 1) Students are strongly advised to refer to the Recommended Course Pattern at the Student Handbook and consult your academic advisor on course selection.
- 2) Students may consult your academic advisor for selection of research postgraduate courses. Applications are made during the course add/drop period by submitting the course add/drop form for postgraduate course. The form is available at the RES website.
- 3) A course of enrollment below 10 may be cancelled.
- 4) Students resuming study after exchange and students transferring to the FinTech / SEEM major from other majors are strongly advised to submit your credit transfer/course exemption applications, if any, **AS EARLY AS POSSIBLE** so as to better facilitate your course selection plan in your remaining study period.
- 5) The course contents of SEEM3550 (a required course) and CSCI3170 are similar. Students should not select CSCI3170.
- 6) ENGG1410 Linear Algebra & Vector Calculus for Engineers was the Faculty Package requirements for students admitted to CUHK 2018-19 and before. ENGG2450 Probability and Statistics for Engineers was under the Faculty Mathematics Foundation requirements for students admitted to CUHK 2018-19 and before. The courses will not be offered. Concerned students who have not fulfilled the requirements for graduation are required to complete and apply for the following course substitutions. Applicable to students in FTEC Major:

- 1) ENGG1120D Linear Algebra for Engineers and ENGG1130A Multivariable Calculus for Engineers are pre-assigned to the FTEC Year 1 and Year 2 transfer-in students.
- 2) FTEC Year 1 students are recommended to take ECON2011 Basic Microeconomics in Term 2. For any problems in course registration, please contact dept@se.cuhk.edu.hk for assistance.
- 3) FTEC2001 FinTech Regulation and Legal Policy and FTEC2101 Optimization Methods are pre-assigned to the FTEC Year 2 and Year 3 students who have not fulfilled the course requirement in 2019-20.
- 4) IERG4130 Introduction to Cyber Security is a required course for FTEC Year 3 and Year 4 students. According to the Announcement declared in Term 1, there are only a few places available for FTEC students in Term 2.

Applicable to students in SEEM Major:

- 1) SEEM4998 Final Year Project I and SEEM4999 Final Year Project II courses are pre-assigned by the Department to the concerned graduating students.
- 2) ENGG2780B Probability for Engineers is pre-assigned to SEEM Year 2 students.
- 3) The following special arrangements are made in addition to the elective courses for Streams of Specializations listed in the Student Handbook:
