WORKSHOP DESCRIPTION

It is well-known that music is a fantastic medium to express our feelings and reflect our inner self. Music is able to create a wonderful group atmosphere and unite the members in group counselling. However, counsellors, social workers and helping professionals find it difficult to use music in their counselling sessions because of their limited music and music therapy techniques. This course is to provide both theoretical foundation and practical techniques of music therapy for any helping professionals who are interested in applying music to enhance their group counselling quality for all ages of clients. This course does not have any musical prerequisite. We welcome all participants who are either musicians or non-musician without any musical background.

OBJECTIVES

Upon completion of this workshop, participants will be able to:

- Understand the creative and therapeutic use of percussion instruments:
- Understand the basic music therapy principle and its application;
- Design and lead a series of musical activities for group counselling.

Dr. Ng Wai Man (PhD, MA, MA, PG Dip, Grad Dip, BSc. BMus) is a Registered Music Therapist (BAMT & HCPC, UK) and a Registered GIM Therapist (FAMI, US). He received formal music therapy training in England (Roehampton and ARU) and GIM training in Australia (Melbourne). He completed his PhD entitled 'The Application of Chinese Music and Chinese Yin-Yang Concept in Guided Imagery and Music' in 2018 from the University of Melbourne. He has been working as a music therapist at the Professional Music Therapy Centre for 16 years. He is also an experienced Adjunct Assistant Professor and Clinical Supervisor for the local universities and organizations to provide music therapy training and supervision for different helping professionals in Hong Kong.
