#### **COURSE DESCRIPTION**

This course studies the nature, form and scope of international business. Topics include foreign environment and major international business activities, such as exporting, direct investment, licensing and other contractual arrangements. Management strategies concerning production, marketing, human resource, and finance in an international context will also be discussed.

- 2. Ted Talk (10%) This is an informal panel session designed to facilitate your active and mutual learning among students. During Week 3 and 4, you will prepare a short Ted Talk (reference: <u>https://ted.com</u>) of <u>no longer than 5 minutes</u>, introducing <u>a latest/emerging global business issue</u>. Examples of global business topics include but not limit to:
  - Opportunities or challenges for Chinese MNEs in Belt and Road Initiatives?
  - Any attractive emerging markets after BRIC?
  - Is it worth investing in Southeast Asia?
  - What if US agricultural subsidies are removed?

- Strategy Analysis (20%) In Week 5, you will take the role of strategic thinker to <u>choose an MNE</u> and complete a strategy analysis of <u>no longer than 10 minutes</u> to <u>analyse and evaluate its global strategy</u>. Please refer to the Presentation Guidelines for details and the Assessment Rubrics for the grade descriptor of Strategy Analysis.
- 4. Test 1 (20%) & Test 2 (20%) You will take two tests during the course. These tests primarily focus on evaluating your understanding of key concepts and theories and critical analysis of materials covered in classes. The questions will be in the form of short cases and/or essays. Please make sure ahead of time that you will be able to prepare the tests.

You are required to <u>take the test on the specified date</u>. <u>Please be PUNCTUAL</u>. Make-up tests can only be approved in advance of the tests <u>if and only if you have a university-excused absence</u> (that is, in a medical conditions or with other compelling reasons that prevents you from attending the tests). You should contact <u>BOTH me and the OAL</u> in writing with documentary evidence <u>no later than 3 days before the tests</u>. Unless due to emergencies, requests submitted after the tests will not be considered. <u>Absence of either tests without permission from the OAL will be given a grade of 'F' for that test.</u>
