- (五) 承辦商/承判商獲准逾夜停泊之車輛,在逾夜停泊時須停放在指定停車場或其設有圍街板之地盤內。

所有收費泊車證之六個月有效周期皆由當年之十月份或四月份開始。

Parking Label (2020-2021) for Approved Individuals

Parking Labels for Approved Suppliers/Contractors

- (1) Approved non-campus based suppliers/contractors of the University who require frequent access to campus are eligible to apply for a <u>PAID</u> parking label for parking between 7:00 a.m. and midnight.
- (2) The applicant must possess a valid driving licence and ownership of vehicle (or authorization from the registered owner).
- (3) A fee of \$1,200 shall be charged for such label each six-month period (or at pro rata basis) or \$300 each for monthly label.
- (4) Replacement for a lost, damaged label or transfer of a valid label to another vehicle will be charged at renewal rate.
- (5) Suppliers/Contractors approved for overnight parking must do so at designated car park or within own hoarding area.

Notes for label holders:

- The six-month cycle for all paid labels starts either in October or April each year.
