The recommendation to revise the exemption criteria of the University's IT Core Requirement was approved.

The recommendation to revise the exemption criteria of two Faculty Package courses for MBChB and Pharmacy students admitted in and after 2015-16 with outstanding results in Hong Kong Diploma of Secondary Education examination and for students admitted against FYFD quota with advanced standing admitted in and after 2015-16 was approved.

The revised Policy on Research, Intellectual Property and Knowledge Transfer was endorsed for approval by the Council.

The proposed revisions to the remarks on exchange participation in students' transcripts, applicable to students joining exchange programmes in Term 2, 2014-15 and thereafter, were approved.

The proposed Regulations on Students of the University were approved.

The proposed revisions to the *General Regulations Governing Undergraduate Studies for Students admitted by The Chinese University of Hong Kong, Shenzhen* adopted by CUHK were approved.

The proposed procedures on the Revocation of Academic Awards were approved.

A vote of thanks to Professor David W. Faure, Wei Lun Professor of History and Professor of History, Professor Vincent H.L. Lee, Professor of Pharmacy, and Professor Zhao Zhenkai (Bei Dao), Professor of Humanities, was recorded for their significant contributions to the University, and in particular in their capacity as members of the Senate upon their retiring from the present post or leaving the University.
