### SUMMARY

Dr. Waiman Cheung is the Director of the Asian Institute of Supply Chains & Logistics, Director of Center of Cyber Logistics, and Executive Director of The Asia-Pacific Institute of Business. Prof. Cheung holds an MBA and a Ph.D. in Decision Sciences and Engineering Systems from Rensselaer Polytechnic Institute. He is currently also a Professor in the Department of Decision Sciences and Managerial Economics in the Faculty of Business Administration, The Chinese University of Hong Kong. His research interests are mainly in aviation, logistics, and supply chain management and information technology.

Dr. Waiman Cheung has investigated how IoT (Internet of Things) technology can be implemented and how it can transform supply chain operations through data analytics. His research pioneered the implementation of IoT and data analytics for complete end-toend supply chains and identified the benefits for each supply chain party.
