INTRODUCTION

Since its establishment in September 1990, the Hong Kong Institute of Asia-Pacific Studies (hereafter, the Institute or HKIAPS) has been promoting and co-ordinating disciplinary studies on Hong Kong, its neighbouring Asian countries and communities within the Asian Pacific region. The Institute aims to serve as a bridge between overseas scholars in Asia-Pacific studies and teaching and research staff at The Chinese University of Hong Kong (hereafter, the Chinese University or CUHK).

The Institute supports two major types of research activities: individual projects funded by or affiliated with the Institute, and long-term inter-disciplinary research programmes constitute the backbone of the activities of the Institute. The latter activities are described at length in the following pages, while the former will be mentioned in particular segments of specific programme reports.

MESSAGE FROM THE DIRECTOR

The past year represented the last year of the first term of the Hong Kong Special Administrative Region (SAR) Administration under Mr. Tung Chee-hwa's leadership. Hong Kong has had a rough passage economically, exacerbated by the 911 terrorist attacks in the United States. From the Institute's standpoint, the year was uneventful until the time for writing this report. What transpired is that two of our colleagues have been invited to join Mr. Tung's newly launched cabinet team, one of his initiatives aimed at turning around Hong Kong's fortunes. On 1 August 2002, Prof. Arthur Li, Vice-Chancellor of the University, stepped down from his university position and became the Secretary for Education and Manpower. Prof. Lau Siu-kai, Associate Director of the Institute since its founding, became Head of the Central Policy Unit, the think-tank for the SAR government. Taking a leave of absence from the Institute, Prof. Lau's appointment is widely applauded because of his prominent media visibility over the years and his balanced and shrewd commentaries. His newly published The First Tung Cheehwa Administration is evidence of his commitment to research on the political dynamics and evolution in Hong Kong. We wish him luck in his new job, where he will have to maintain a prudent balance between being the academic community's "inside" voice and acting as a vehicle to help the populace understand the administration's policies. Prof. Sung Yun-wing has since been appointed Associate Director of the Institute.

In the second year since relocating to the Esther Lee Building, the Institute has had a normal run of research activities and publications. Six seminars and conferences have been held, details of which may be found in the programme reports that follow. What might be singled out for mention here is the seminar on "The Challenges and Opportunities for the Chinese Economic Sphere after China's Entry to WTO," held on campus on 19-20 December 2001, under the auspices of the Shanghai-

Hong Kong Development Institute, with administrative and other support provided by this Institute. The seminar could not have been held at a more opportune time, as China was only formally admitted to WTO membership in November 2001, after over 15 years of protracted negotiations. A monograph arising from the proceedings is in the final stages of publication.

The volume marking the tenth anniversary of the founding of the Institute appeared as New Challenges for Development and Modernization: Hong Kong and the Asia-Pacific Region in the New Millennium in April 2002, exactly two years after the conference was held. It is a timely publication because some of the chapters focus on the socio-economic transformation of Hong Kong since the handover. Dr. Lam Kin-chung, a Trustee of Shaw College,

has provided a grant to partly fund the publication of the volume, for which I remain very grateful.

Looking forward, the Institute has entered into a collaborative venture with the Hong Kong Housing Authority to appraise the development of public housing in Hong Kong since 1953, when the then colonial government was forced into direct intervention in housing provision following the disastrous Shek Kip Mei squatter fire. The publication of two volumes, in English and Chinese, has been planned to mark the golden jubilee of public housing in Hong Kong. Preparation for the volumes, with the participation of well-known scholars and professionals in Hong Kong, is well under way.

During the past year, the Institute continued to expand and consolidate contacts within and outside the Hong Kong community. We received a generous donation from Pacific Century CyberWorks Limited (PCCW) to fund public policy research. Arising from this donation, a seminar on "Hong Kong's Telecommunications Policy" was held, in collaboration with the *Ming Pao Daily News*, on 26 February 2002. A series of policy forums are being planned for the coming year, focusing on important policy issues of the time.

In terms of training activities, the Institute continued to organize an Introductory China Course with the Hong Kong Civil Service Training and Development Institute. This course has proven to be popular over the years. In addition, at the request of the Tianjin municipal authorities, two training courses on human resources management were organized for about 30 participants each in April and September 2001.

The Hong Kong APEC Study Centre, which had been hosted by the Institute for two years, was officially moved to the City University of Hong Kong in September 2001. There is much that needs to be done in terms of information sharing and development of mutual interests with member APEC Study Centres. We wish the Hong Kong Centre well in its continuing efforts to project Hong Kong's image and to play its role in furthering Hong Kong's interests.

The past year also saw the Shanghai-Hong Kong Development Institute fully integrated with the normal work of the Institute. Most of the former Institute's publications and some of its research activities are undertaken by the staff of this Institute. A full report of the first year of activities of the Shanghai-Hong Kong Development Institute may be found in its *Shanghai-Hong Kong Annual 2001* published in early 2002.

Finally, the internal functional units of the Institute have had a busy and successful year. The Institute has to date published 55 research monographs since its inception, 3 during the year under review. The corresponding numbers for occasional papers are 127 and 10. The Telephone Survey Research Laboratory, established since 1995, has cumulatively undertaken 380 commissioned surveys, with 60 undertaken during the past year. The Documentation Unit has also successfully adjusted to its new premises in the Esther Lee Building. Its project of digitizing past Hong Kong newspapers has continued.

With Hong Kong, China and the Asia-Pacific region at large in the throes of rapid changes in the Information Age, there is a need for quality research to enable policy-makers and planners to make rational and prudent decisions. The Institute is prepared to contribute to maintaining Hong Kong's competitive edge and towards making it a better place to live and to work.

Prof. Yeung Yue-man

With basic training in geography in Hong Kong, Canada and the United States, Prof. Yeung has had a rich and variegated career that has spanned teaching, research, international development and university administration. He had been away from Hong Kong for almost two decades, studying in North America and working in Singapore and Canada before being appointed in 1984 chair Professor of Geography at this University. Prof. Yeung has travelled to most countries in the Asia-Pacific region and has worked with many Asian research institutes and researchers. His research interests lie mainly in Asian cities, lowcost housing, and policy studies and design for development, with particular reference to Pacific Asia. He has published numerous books and articles in international learned journals on these subjects. Apart from being the Director of the Institute, Prof. Yeung leads the Urban and Regional Development in Pacific Asia Research Programme. Prof. Yeung plays a very active role in serving the Hong Kong community through memberships in several public bodies providing key urban services, and he participates collaboratively in many regional and global research projects.

Prof. Lau Siu-kai

Prof. Lau Siu-kai graduated from the University of Hong Kong in 1971 with a B.Soc.Sc. degree in sociology and economics, and from the University of Minnesota in 1975 with a Ph.D. in sociology. He joined CUHK in 1975. Prof. Lau's major research interests are comparative political and social development, society and politics in Hong Kong, and political development in traditional and modern China. He tackles both macroscopic and microscopic issues, such as political culture and political behaviour. His favourite approach is the comparative historical method. His publications include *Society and Politics in Hong Kong* (1982) and, with Prof. Kuan Hsin-chi, *The Ethos of the Hong Kong* (1982) and, with Prof. Kuan Hsin-chi, *The Ethos of the Hong*

Kong Chinese (1988). He is the Director of two research programmes: Political Development of Hong Kong and Social Indicators and Social Development of Hong Kong.

Prof. Sung Yun-wing is currently Professor and Chairman of the Department of Economics, and co-director of the Hong Kong and Asia-Pacific Economies Research Programme at the Chinese University. He is also Editor of the Asian Economic Journal, Book Review Editor of Pacific Economic Review, Corresponding Editor of Asian-Pacific Economic Literature, and is member of the editorial board of China Review. His research interests include international trade, economic development, the Hong Kong economy and the Chinese economy.

Prof. Fanny Mui-ching Cheung

Prof. Fanny M. Cheung, Ph.D. (Minnesota), established the Gender Research Programme at CUHK in 1985. When she was Dean of the Faculty of Social Science in 1995-1996, she initiated the Gender Studies Programme. An active advocate for women's development in the community and a recognized women's leader in the Asia-Pacific region, she served as the founding chairperson of Hong Kong's Equal Opportunities Commission from 1996-1999. Her research interests in gender issues include gender roles, violence against women, women's health and gender equality. Other research interests in psychology include personality assessment and cross-cultural psychopathology.

Prof. Kuan Hsin-chi, Director of the South China Programme, is Professor of Government and Public Administration and Chairman of the Department; he is also the Director of CUHK's Universities Service Centre for China Studies. He has coauthored *The Ethos of the Hong Kong Chinese* and co-edited the first two volumes of *China Review* and *China Review* 1992, as well as *China Review* 1997. He has contributed to *The China Quarterly*,

Studies in Comparative Communism, Asian Survey, Journal of Comparative and Commonwealth Studies and Pacific Affairs.

Prof. Liu Pak-wai

Prof. Liu Pak-wai is currently Professor of Economics, Pro-Vice-Chancellor of the Chinese University and co-director of the Hong Kong and Asia-Pacific Economies Research Programme at the Chinese University. He is also Research Director of the Hong Kong Centre for Economic Research, Secretary General of the East Asian Economic Association, nominator of Fukuoka Asian Culture Prizes and Advisory Editor of Education Journal. In public service he serves as member of the Economic Advisory Committee, Commission on Strategic Development, Council of Advisors on Innovation and Technology, Hong Kong Committee on Pacific Economic Co-operation, Panel of Arbitrators, Process Review Panel for the Securities and Futures Commission, Skills Upgrading Scheme Steering Committee, and Task Force on Employment. His research interests cover the areas of applied theory, labour market and employment, and the Hong Kong economy. Besides a continuing interest in economic theory, Prof. Liu is also interested in the empirical aspects of economics.

Dr. Gary Moon-cheung Shiu

After graduating from George Mason University with a Ph.D. in economics, Dr. Shiu worked for a non-profit think-tank (Employment Policy Foundation) specializing in labour issues in Washington DC. Upon his return to Hong Kong, he first served as a senior economist for China Everbright Holdings Company Limited, a "Red Chip" conglomerate. Later on, he joined the US Treasury's Asia Representative Office as an economist. He was a Regulatory Affairs Manager with the Hong Kong Telecommunications Authority, the local telecom watchdog, before coming to the Institute. He is now the co-ordinator of the Institute's Documentation Unit. His research interests include new institutional economics, public choice and economics of transition.

Prof. Tan Chee-beng

Prof. Tan Chee-beng obtained his Ph.D. from Cornell University in 1979. He is currently Chairman of the Department of Anthropology at the Chinese University and Director of the Cultural Relations and Identities in East Asia Research Programme. His research interests include cultural change and identity, ethnicity and ethnic relations, and indigenous peoples and development. He has been particularly interested in the study of Chinese overseas and, in recent years, has also conducted research in mainland China. His publications are in these areas, including Chinese popular religion.

Ms. Wan received her B.S.Sc. and M.Phil. in sociology from CUHK. She is experienced in sample surveys and Hong Kong studies. Her major research interests are the status of women and the state of the environment. She is responsible for the Institute's publications and is co-director with Prof. Lau Siu-kai of the Social Indicators and Social Development of Hong Kong Research Programme.

He is currently a Researcher Officer and co-ordinator of the Telephone Survey Research Laboratory of the Institute. Prof. Yip Hon-ming (Ph.D., University of California, Los Angeles) has published on gender/women's history, history of the overseas Chinese, modern and contemporary Chinese socioeconomic history, and local history of China and Hong Kong. Being a member of the Association of the Advancement of Feminism, Hong Kong Women Christian Council and other community organizations, she considers the co-ordination of teaching, research and social practice the most challenging work at present. Taking power in history as her focal point of reflection in recent years, she is interested in exploring the historical contexts of the development and change of power operation in human society; she is also interested in ways of exposing the historical roots of human manipulation and resistance in daily life. Related issues include marginalization and subordination, and subversion and struggle in the fields of gender, class and ethnicity.

Objectives

This inter-disciplinary research programme is designed to facilitate and consolidate diverse research interests in cultural development within and cultural interactions among East Asian countries at the Chinese University as well as in the broader Hong Kong academic community. Cultural relations among Asia-Pacific countries have gained prominence in the post-cold war era, as cultural activities carry new political meanings and commodified cultural items are promoted and traded across national and regional boundaries. The research projects focus on a broad array of identities and cultural relations in East Asia, including media and popular culture; youth culture and education; ethnic, national and pan-Asian identity; cultural tourism; cosmopolitan culture and democratization; and food, cuisine and cultural change.

There are four categories of research activities in the Cultural Relations and Identities Research Programme. They are: tradition, change and identity; culture, identity and nationalism; cultural unity and diversity in Asia; and transnationalism and global culture. During the past year, programme members were

active participants in conferences and have published in journals and books. Four books edited by programme members were published during the year, namely *Luyou*, renleixue yu Zhongguo shehui (Tourism, Anthropology and China) (edited by Yang Hui, Tan Chee-beng and Sidney C. H. Cheung, 2001), Consuming Hong Kong (edited by Gordon Mathews and Lui Tai-lok, 2001), Changing Chinese Foodways in Asia (edited by David Y. H. Wu and Tan Chee-beng, 2001) and The Globalization of Chinese Food (edited by David Y. H. Wu and Sidney C. H. Cheung, 2002).

Scholars from the Social Science, Humanities, Medicine, Business Administration, Education and other fields have participated in the Centre's various research activities. Conference and Workshop

The International Conference on "Chinese Culture and Women" was held on 13-15 June 2002 in collaboration with the Gender Studies Programme and Women's Studies Centre of Peking University, China. At the Opening Ceremony, the Vice-Chancellor of Peking University and the Director of the Gender Research Centre gave their welcome speeches. The two-day presentation and discussion covered various gender-related topics on Chinese culture, including religion, identity and social development. Prof. Fanny M. Cheung, Prof. Yip Hon-ming and Prof. Wong Wai-ching represented the Gender Research Centre. Six papers from CUHK were read at the Conference.

The Annual Gender Role Workshop: "Life Long Education and Economic Empowerment for Women" was held on 25 May 2002. Mrs. Sophie Leung, Chairwoman of the Women's Commission, inaugurated the Workshop. Participants included academics, students, members of women's groups, women's service providers and practitioners in the field of education.

Attendees engaged in active discussion on the future development of government policy on life-long education, as well as its limitations and possibilities regarding Hong Kong women's lives.

Asian Economic Journal

This is the twelfth year in which Osaka International University and our Programme jointly publish the Asian Economic Journal for the East Asian Economic Association. Since 1997, the number of issues published each year has been increased from three to four. From 1997 onwards, Prof. Liu Pak-wai has served as the Secretary General of the East Asian Economic Association while Prof. Sung Yun-wing has served as Managing Editor of the journal till the end of 2000. In 2001, Prof. Kwong Kai-sun took over as Managing Editor and Prof. Sung Yun-wing served as Editor.

Prof. Liu Pak-wai serves as member of the Economic Advisory Committee, Commission on Strategic Development, Council of Advisors on Innovation and Technology, Task Force on Employment, Panel of Arbitrators, Process Review Panel for the Securities and Futures Commission, Skills Upgrading Scheme Steering Committee, and Hong Kong Committee on Pacific Economic Co-operation. He is also Research Director of the Hong Kong Centre for Economic Research, Secretary General of the East Asian Economic Association, member of Management Committee of Hong Kong Institute of Economic and Business Strategy, nominator of Fukuoka Asian Culture Prizes, and Advisory Editor of the Education Journal.

Its readership is expected to increase as economists world-wide focus their attention on the economic successes and problems of the Asia-Pacific region. The Editorial Committee is very broad-based. It includes leading economists from all major East and Southeast Asian countries. Because the journal is edited, printed and published at CUHK, it bears the name of CUHK together with Osaka International University on the front cover. The Secretariat of the East Asian Economic Association is also located at CUHK using HKIAPS as its address. The journal and the location of the Secretariat have promoted the image of CUHK in general, and HKAPE and HKIAPS in particular, as institutions active in research within the Asia-Pacific region.

Political Development of Hong Kong

Prof. Lau Siu-kai Programme Director:

Objectives

The core areas of study of this Programme include: political changes in Hong Kong, driven by political reforms, the return of the territory's sovereignty to China in 1997, the mode of governance of the HKSAR government and socio-economic changes. A wide range of research topics have been covered and more will be included in the future. At present, the Programme concentrates on issues related to popular elections, relationship between China and Hong Kong, regime-building, institutional changes, policy reforms, political leadership and political conflicts.

Data Collection

The Programme has a collection of research materials on Hong Kong's political scene. Aside from newspaper clippings, the Programme also collects unpublished research reports from various social and political organizations.

With its focus on local electoral studies, the Programme has built up a comprehensive collection of documents and materials related to elections and electoral campaigns in Hong Kong. The collection forms a useful database for the study of future elections in Hong Kong.

International Exchange

The Programme is also a partner of a project on the comparative study of political culture and political participation in Hong Kong, Taiwan and China. This cross-cultural study is coordinated by Prof. Andrew Nathan of Columbia University. Researchers come from Hong Kong, China, Taiwan and the United States. The Hong Kong team (composed of Prof. Lau Siukai and Prof. Kuan Hsin-chi) is responsible for a questionnaire survey in Hong Kong. The survey was completed in the summer of 1993. Three workshops have already been held in August 1992, March 1993 and July 1995 in Honolulu, Los Angeles and Hong Kong, respectively.

The research project, "The Legislative Council Elections in 1998," has attracted attention overseas and subsequently been incorporated into a 14-nation collaborative project, "The Comparative National Elections Project (CNEP)," co-ordinated by Prof. Richard Gunther of Ohio State University. A looser affiliation has also been established with another and larger international research project, "Comparative Study of Electoral Systems (CSES)," co-ordinated by Prof. Steven Rosenstone of the Institute of Social Research at the University of Michigan.

Research Activities

Both Prof. Lau Siu-kai and Prof. Kuan Hsin-chi continue to study the patterns of political changes in Hong Kong, particularly in areas such as political leadership, regime building, political culture, development of political parties and emergent political issues.

Since many commissioned research projects of the Telephone Survey Research Laboratory of the Institute are about local politics, the Programme has provided technical and staff support to the Laboratory and is instrumental in its smooth operation.

The following research projects are currently sponsored by the Programme:

"Political Change and the Civil Servants in Hong Kong" by Prof. Lau Siu-kai. The project is funded by the Chinese University.

"Political Culture and Political Participation in China, Taiwan and Hong Kong" by Prof. Lau Siu-kai, Prof. Kuan Hsin-chi, Prof. Andrew Nathan (Columbia University), Prof. Hu Fo (National Taiwan University), Prof. Chu Yun-han (National Taiwan University) and Prof. Shi Tian-jian (Duke University). The project is funded by, inter alia, the National Science

Foundation, the Chiang Ching-kuo Foundation and the Luce Foundation. The questionnaire survey launched in Hong Kong was partly funded by the Center for Pacific Rim Studies, University of California, Los Angeles. Participants are in the process of writing chapters to be included in a forthcoming book.



Social Indicators and Social Development of Hong Kong

Programme Directors: Prof. Lau Siu-kai

Ms. Wan Po-san

Objectives

The Programme focuses on the measurement and study of social development in Hong Kong. Its prime purpose is to build up a set of longitudinal data on the subjective and objective dimensions of social conditions and social change. It is hoped that the availability of these data will facilitate not only the analysis of patterns of social change and the exploration of social issues and problems but also contribute to the evaluation and formulation of public policy.

Conferences

"2002 Conference on Social Image and Social Indicators: Hong Kong and Taiwan"

This conference was partly funded by Mr. Richard Liu and was organized in co-operation with the Institute of Sociology, Academia Sinica. It was held on 14-15 June 2002 in Taipei. Fourteen papers were presented.

"The Third Conference on Social Stratification Studies in Chinese Societies"

This conference, organized in collaboration with the Centre of Asian Studies of the University of Hong Kong and the Centre for Social Policy Studies of the Hong Kong Polytechnic University, is scheduled to be held on 28-30 November 2002 at the Chinese University. Over 30 scholars from mainland China, Taiwan and Hong Kong have been invited to participate.

Research Activities

Highlights of the main activities during the past year are underlined as follows:

"Social Indicators Survey Series" co-ordinated by Prof. Lau Siukai and Ms. Wan Po-san

The Programme has been conducting a series of biennial territory-wide household surveys since 1988. These periodic surveys aim to measure the scope and extent of significant aspects of social change in Hong Kong by focusing on the perception, values, feelings, aspirations and sense of well-being of the Hong Kong people on various important aspects of their daily lives.

The survey, "Social and Political Change in a Period of Reform and Readjustment: Indicators of Social Development in Hong Kong 2001," is funded by the Research Grants Council's Competitive Earmarked Research Grant and is conducted in collaboration with the Centre for Social Policy Studies of the Hong Kong Polytechnic University and the Centre of Asian Studies of the University of Hong Kong. It focuses on social issues and political problems engendered by Hong Kong's sudden economic downturn, its long and painful road to economic recovery and the HKSAR government's multifarious reform initiatives.

CUHK team members include Prof. Lau Siu-kai, Prof. Kuan Hsin-chi, Prof. Deborah Davis, Prof. Chan Kin-man, Mr. Simon Ng and Ms. Wan Po-san. Special topics in the 2001 survey included: (1) education, work and economic values; (2) family and Hong Kong-mainland relation; (3) political attitudes; (4) housing and legal culture; and (5) poverty. The survey fieldwork was launched in May 2001. A general report, entitled *Indicators of Social Development: Hong Kong 2001*, is expected to be published by the end of 2002.

"A Comparative Study of Social Networks and Mental Health in Hong Kong and Beijing" by Prof. Rance P. L. Lee (Principal Investigator), Prof. Chan Ying-keung, Prof. Peng Yusheng and Prof. Gina Lai

This project is funded by the Research Grants Council's Competitive Earmarked Research Grant and is conducted in collaboration with the Peking University. This is a large-scale survey on the roles of ego-centred social networks in the mental health process in Hong Kong and Beijing. It aims to address two major issues: (1) How do the structures and processes of social networks interplay to affect mental health status? (2) How are social networks and related mental health outcomes shaped and constrained by micro socio-economic factors (e.g., gender, age and social class) and macro socio-economic contexts (e.g., cultural tradition, organization of work and community)? Both surveys were conducted in the summer of 2000. Efforts have been made to analyze the composition of social support networks, the reliability and validity of mental health measurements, the patterns of perceived social support and their effects on mental health, and the impact of personal network structures and functions on life satisfaction.

"A Comparative Study of the Social Image of Taiwan and Hong Kong"

CUHK team: Prof. Lau Siu-kai and Ms. Wan Po-san Taiwan team: Prof. Yi Chin-chun, Prof. Chang Ying-hwa, Prof. Chiu Hei-yuan, Prof. Fu Yang-chih and Prof. Michael Hsinhuang Hsiao

This project is conducted in collaboration with the Institute of Sociology of the Academia Sinica, Taiwan. A telephone survey will be conducted once or twice a year to gauge the perception, values and subjective well-being of people in both societies. The core questions of the questionnaire will be kept unchanged as far as possible so as to detect social trends and changes, while questions on special topics will be flexible enough to reflect changes in social conditions. The second survey, focused on cultural life, was carried out in November 2001.

"Hong Kong Social Attitudes Survey: 2001" by Prof. Kenneth Chau, Prof. Joseph M. Chan, Prof. Stephen W. K. Chiu, Prof. Clement Y. K. So, Prof. Ting Kwok-fai and Prof. Wong Chack-kie

This project is funded by Mr. Richard Liu and is conducted in collaboration with the Faculty of Social Science. Major topics of this territory-wide representative household survey included social welfare, mass media and information technology. The survey fieldwork was launched in May 2001. A general report is expected to be published by the end of 2002.

South China

Programme Director: Prof. Kuan Hsin-chi

Introduction

When established ten years ago, the Programme was designed to encourage research activities by faculty as well as graduate students through awarding research grants and postgraduate fellowships. There had been no limitation as to the discipline or topics, except that the focus must be on South China. Starting two years ago, the scope of research had been extended to cover the whole of China and greater emphasis has been placed on the development of in-house team projects. As of today, three team projects have been formed: the Intergovernmental Relations Project, the Research Project on Civil Society, and the Political Economy and Regional Disparities Project. It is expected that the Programme will change its name in due course to reflect the new development.

Research Activities

"Intergovernmental Relations Project" co-ordinated by Prof. Wu Guoguang

This project was formed in early 2001. It has organized two academic events in the past year. First, a panel on Intergovernmental Relations in Greater China was organized for the annual conference of the Hong Kong Association of Political Science held on 4 May 2002, at the City University of Hong Kong. Two papers, one by Prof. Kuan Hsin-chi and Ms. Kitty Poon, and the other by Prof. Yu Xingzhong, were presented, while several other members of the Project served as discussants. Second, the Project co-sponsored with its Taiwan partner, the National Chinan University, a conference under the title of "Prospecting the New Century: Inter-governmental Relations in Taiwan, Hong Kong, and Mainland China." It was conceived as

the first of a series of such conferences. The conference was held in Taipei on 18 May 2002, with 12 paper presentations and two sessions of roundtable discussions. Four colleagues from our Project contributed papers, as follows:

Ms. Kitty Poon and Prof. Kuan Hsin-chi, "The Hollowing Out of the 'One Country Two Systems' Framework: China's Hong Kong Policy in a Changing Context";

Prof. Wang Shaoguang, "The Political Logic of Fiscal Transfers in China";

Prof. Peter Cheung, "Intergovernmental Relations in South China";

Prof. Yu Xingzhong, "Constitutional Interface between Hong Kong and the Mainland."

Two colleagues (Prof. Linda Li and Prof. Wu Guoguang) served as commentators. After the conference, some colleagues visited the National Chinan University and took part in a planning workshop with faculty members of the Department of Public Administration and Public Policy on matters of future cooperation.

"Research Project on Civil Society"

The project was established in early 2002 to replace "the Comparative Study of Civil Organizations in Chinese Societies." Prof. Chan Kin-man from the Department of Sociology was appointed as the convener of the project. Members include Prof. Kuan Hsin-chi and Prof. Wang Shaoguang of the Department of Government and Public Administration, Prof. Lui Tai-lok from the Department of Sociology, and Prof. Joseph Man Chan from the School of Journalism and Communication. The project aims at promoting research on civil society in mainland China, Taiwan and Hong Kong. The project will hold meetings and conferences to facilitate intellectual exchange among scholars in CUHK and other institutes on the subject of civil societies. In April 2002, together with the Research Institute on Guangdong Development at Zhongshan University in Guangzhou, the project established the Research Center on Civil Society in South

China, based in Zhongshan University. The centre represents a long-term commitment by CUHK and Zhongshan University to the study of the social, economic and political impacts of the development of civil society in this region. The centre will concentrate on the study of business organizations in Guangdong from late Qing to the present.

"Political Economy and Regional Disparities Project"

This principal director of the project is Prof. Tsui Kai-yuen from the Department of Economics, with Prof. Wang Yougiang, also from the Department of Economics, and Prof. Hu Angang, of Tsinghua University, as co-investigators. The project, funded by the Research Grants Council, has entered its third year and is due to be completed soon. Current research activities concentrate on (1) examining how Chinese political institutions that are quite different from market preserving federalism can explain the seemingly paradoxical fiscal behaviour of local governments, (2) exploring the forces that shaped China's interprovincial inequality in the last five decades, and (3) studying the fiscal relations between central and local governments embedded in a vertical control system where local officials are appointed by the central government. This year's outputs include a published paper (see under the "Publications" section below) and two draft papers, "Accounting for Changes in China's Regional Disparities" and "Decentralization with Political Trump: Revenue Collection and Control," both by Prof. Tsui Kai-yuen and Prof. Wang Youqiang. Other than the three papers mentioned above, a data set of Chinese fiscal data has been created and may be used to explore a wide range of issues on Chinese public finance.

Urban and Regional Development in Pacific Asia

Programme Director: Prof. Yeung Yue-man

Objectives

The Programme promotes and facilitates research on economic development and social change in the Asia-Pacific region through studies on urban and regional development. In the past the Programme has supported a large number of research projects on key urban development and globalization issues and China's regional development and economic reforms. Many books and other publications have appeared and have received enthusiastic support. Since last year, a new direction has been embarked upon in focusing research efforts on China's western region.

The Programme has continued to receive financial support from the Lippo Group, which has generously provided an annual grant to the Programme since 1993. For this we are grateful to Dr. Stephen Riady and Mr. J. P. Lee, MBE, OBE, JP, for their friendly encouragement and much-valued confidence in our work. During the past year, Dr. Lam Kin-chung, a Trustee of Shaw College, also provided financial support, for which we wish to extend our heart-felt thanks and appreciation.

Conferences and Invited Presentations

During the past year, the Programme did not organize any conference or seminar. It was busy in following up the work necessary to bring out books arising from recent conferences. Specifically, book arising from the international conference marking the tenth anniversary celebration of the Institute held in April 2000, and another one focused on China's West held in December 2000 have been published, as reported below.

Research Activities

Two books arising from previous conferences, mentioned earlier, which the Programme undertook the responsibility of editing, have appeared in print. Details may be found below.

The Programme has continued to contribute to the work of the Urban Population Dynamics Panel under the auspices of the United States' National Research Council. The final report has been completed and is being reviewed for publication. The Programme has been involved in this important and worthy enterprise over the past three years.

Early in 2002, via the Institute, the Programme was invited by the Hong Kong Housing Authority to participate in a collaborative effort to produce two books marking the fiftieth anniversary of Hong Kong's involvement in public housing development in 2003. The two books, in Chinese and English, have included top scholars and professionals in the field of housing as contributors. The books will be published by the Chinese University Press in 2003.

Another book project on China's western development has been progressing well. It has the participation of a large number of contributors from this University and research institutes in China. It is also scheduled for publication in 2003.

External Liaison

Dr. Timothy Ka-ying Wong is responsible for external liaison work of the Institute. This is a duty of a rather regular and routine nature. The overall objective is to publicize the activities of the Institute so that the public and concerned groups or persons can be informed of our work, make use of our research results and take part in our activities. External liaison has three main components:

Publicity about our publications includes preparing and issuing press releases to the media, distributing information sheets and order forms to relevant institutions and individuals, and liaising with our distributors.

Publicity about our conferences and seminars includes preparing and issuing press releases, sending invitations and publicity materials to the media, arranging and facilitating the reporting work of the press, and assisting the organizing committees to handle enquiries and public relations.

Liaison with overseas institutions and individuals includes the handling of enquiries and the exchange of information and publications.

During the last year, over 60 scholars from the mainland and overseas have visited the Institute, 6 seminars or conferences have been held, and 10 occasional papers and 3 research monographs have been published. On the whole, our guests and visiting participants were pleased, and the coverage of our seminar/conference activities by the media was satisfactory. Our publications were also made known and distributed in an effective manner.

Telephone Survey Research Laboratory

Co-ordinator:

The Laboratory

Established in May 1995, the Laboratory can handle over 30 telephone lines, all connected to the CATI (Computer Assisted Telephone Interview) system operated through a main server. It can cope with the demands of large samples under time constraint.

Objectives

- a. To provide a telephone survey laboratory to researchers at the Chinese University who want to use a telephone interview technique to facilitate their research.
- b. To enable the development of new research interests using the telephone interview method.
- c. To collect panel public opinion data of academic and social value.
- d. To serve as a link between the Chinese University and the public by regularly offering results of survey polls on public issues.

Accomplishments

Over 380 commissioned surveys have been completed since the establishment of the Laboratory (60 surveys in the past year).

Our survey findings have been widely covered by the media, thereby helping to raise the profile of the Institute and the Chinese University.

The Laboratory has attracted an increasing number of researchers from academic circles and the media who want to use telephone survey as an alternative method of data collection.

With the improving financial situation, we have designed and launched our panel surveys for academic research.

We have trained and pooled over 50 experienced interviewers from amongst CUHK students as well as students from other universities, providing them with not only a good source of income but also the valuable experience of conducting telephone survey research.

We have conducted several seminars for secondary school and technical college students and introduced them to the methodology and interpretation of opinion polling.

Policy

The Laboratory welcomes the sponsorship or commission of surveys; it is also open to collaboration with interested persons or organizations.

Documentation Unit

In tandem with the relocation of the HKIAPS, the Documentation Unit (DU) has a new home as well. The DU is now located at Room 502 of the Esther Lee Building.

The DU holds a vast collection of books, papers, journals and other reference materials on countries around the Asia-Pacific region. Deserving special mention is our collection of Hong Kong newspaper clippings with broad coverage from the 50s to August 2000. In addition, the DU carries a large number of unpublished surveys on many different social issues.

During the past year, electronic archiving of our Hong Kong newspaper clippings continues. Progress is slow but steady. Because of the poor quality of some previously scanned images, a substantial portion of our student helpers' effort is now devoted to the restoration of old images. Where restoration is not an option, the original newspaper clippings were rescanned. Thus far, about 80% of our newspaper clippings dated from the 50s to the 70s has been digitally archived.

From July 2001 to the mid June 2002, altogether 286 users visited the DU, with students continuing to be the core group visitors. Outside visitors were the second largest group of users. With the train station just steps away, DU should now be more easily accessible to outside visitors.

During the past year, DU has received well over 392 items on Hong Kong alone. The Asia-Pacific collection has expanded as well. Over 200 items have been added to our collection. Of these, 145 are books/surveys while periodicals and CD-Roms account for the rest. As of mid-June 2002, DU boasts a collection of 42,250 copies of books, periodicals and other reference materials.

HKIAPS publications aim to disseminate and promote social science research on social, economic and political development of Hong Kong and the Asian Pacific region. It is hoped that extensive and effective dissemination of our research findings will broaden their intellectual and social impact, and solicit more donations for applied social science studies.

Scholars both inside and outside the Chinese University are welcome to submit manuscripts for consideration. Manuscripts received are evaluated by the Editorial Committee in collaboration with invited reviewers of relevant specialities. Publication priority is given to the results of research undertaken by the academics affiliated with the Institute and related to the domains of the established strategic research programmes.

Four publication series, namely the Research Monograph Series, Occasional Paper Series, Shanghai-Hong Kong Development Institute (SHKDI) Occasional Paper Series and USC Seminar Series, are regularly produced. The first three series are mostly the results of research undertaken by scholars at the Institute. The USC Seminar Series publishes selected research papers presented at the Universities Service Centre for China Studies seminars. In addition, the Institute publishes the *Asian Economic Journal* for the East Asian Economic Association.

Civil Service Courses

As before, the Institute has co-operated with the Hong Kong SAR government's Civil Service Training and Development Institute (CSTDI) in organizing courses for general officers and front-line supervisors (i.e., officers on Master Pay Scale point 10 and above) in the past year.

The Institute helped to organize Module II of the Introductory China Course three times in the last year. Five professors from the Chinese University, all experts in their respective fields, were invited to deliver lectures for the course over a three-day session. Topics covered included housing and social security reform, anti-corruption policy and its social impact and industrialization and its impact on environmental protection. Responses from course participants were positive.

Training for Tianjin Municipal Government Officials

On 18-27 September 2001, the HKIAPS organized a training course on human resources management for officials from the Tianjin municipal government. In total, 30 officials participated. Professors from other universities in Hong Kong joined those from CUHK in delivering nine lectures over a two-week period. Topics covered ranged from the government's role in Hong Kong's economy to how performance appraisals are conducted. The response was positive and the Institute will organize another training course again this October.
