

INTRODUCTION

Since its establishment in September 1990, the Hong Kong Institute of Asia-Pacific Studies (hereafter, the Institute or HKIAPS) has been promoting and coordinating inter-disciplinary studies on Hong Kong and neighbouring Asian countries and communities within the Asia-Pacific region. The Institute aims to serve as a bridge between overseas scholars in Asia-Pacific studies and teaching and research staff at The Chinese University of Hong Kong (hereafter, the Chinese University or CUHK).

The Institute supports two major types of research activities: individual projects funded by or affiliated with the Institute, and long-term inter-disciplinary research programmes that constitute the backbone of the activities of the Institute. The latter activities are described at length in the following pages, while the former will be mentioned in particular segments of specific programme reports.

MESSAGE FROM THE DIRECTOR

This is the 17th and the last message I write as Director of the Institute since it was established in September 1990. I consider it proper that I should review the major progress that Institute has accomplished during this period before attention is turned to what transpired in the past year.

When the Institute was established, skepticism was expressed in some quarters if we might be presumptuous on our part to preface our Institute with the term "Hong Kong." As it has turned out, we are indeed the flagship institute in Hong Kong worthy of bearing the Asia-Pacific label, as judged by our publication output, local recognition and overseas collaboration. Our past annual reports would bear ample evidence that we have established active and durable links with a large number of universities and research institutes outside Hong Kong. International agencies that have called on our services are too numerous to enumerate. Our special publication marking the first 15 years of our existence in 2005 would be another source to appreciate our imprint both in Hong Kong, and in the Asia-Pacific region and beyond.

It was the beginning of a momentous period when the Institute was set up in 1990, heralding a sustained phase of rapid economic transition in China with Deng Xiaoping's famous southern tour in 1992, the promulgation of the Basic Law in Hong Kong in April 1990, and, personally, my return to teach in the Department of Geography in that year after completing a term of over four years as University Registrar. True to the original design of the programmes we made out for the new Institute, the link between Hong Kong and Mainland China in our research focus has been steadfastly adhered to up to now.

During the past 17 years, when Hong Kong and Mainland China both underwent rapid economic growth and social transformation, the need for quality social science and policy-relevant research has grown in tandem. The Institute has responded by strengthening its organizational ability and resources. In 1995, our Telephone Survey Research Laboratory was established, with Timothy K. Y. Wong in charge, and increasing community recognition in Hong Kong. Three research centres, namely Gender Research (2000), Public Policy (2005), and Quality of Life (2006), have been established.

In the period under review, the Institute has physically moved twice, first from the initial set-up in Fung King Hey Building to Tin Ka Ping Building, and since 2001, to our present premises in Esther Lee Building. However, the research and support staff personnel have been remarkably stable, apart from the normal attrition and retirement. The most noteworthy change in this respect was the appointment in 2002 of Professor Lau Siukai as Head of the Central Policy Unit, a position he continued to hold with the new HKSAR government in July 2007. The leadership and direction of the research programmes have essentially continued. Since its establishment, the Institute has served under four Vice-Chancellors and it is my pleasure to acknowledge their whole-hearted and unstinting support for the Institute and its activities. Thanks are also due to Professor Rance Lee, who has served from the beginning as Chairman of the Management Committee, providing effective leadership. Personally, I am indebted to Wan Po-san and Timothy K. Y. Wong, respectively Research Officer and Research Associate Professor, and Janet Wong, senior personal secretary, for dependable assistance and encouraging support all these years.

In terms of institutional collaboration, it is such a long list I hesitate to recount. Nevertheless, some of the notable links include that with Yale University, whose Council on East Asian Studies, along with our South China Programme, was the recipient of a huge US\$6 million grant from Dr. Lee Shau-kee and Dr. Cheng Yu-tung in 1991 for 10 years to undertake

collaborative research and training focused on South China in the area south of the Yangtze River. By virtue of my appointment as Director of the Commonwealth Geographical Bureau, 1992-1996, its Silver Jubilee Symposium was brought to this campus in 1994, as well as an earlier annual conference. The Institute was appointed the founding Hong Kong APEC Study Centre, 1998-2000, which was featured in the programme of the international conference marking the tenth anniversary of the founding of the Institute in 2000. By way of training, the Institute collaborated with the Civil Service Training and Development Institute years before the handover and thereafter in a series of training courses aimed at preparing senior civil servants with an understanding of the economic, political and social make-up of China. The Institute also conducted several rounds of training for the officials of the Municipality of Tianjin in modern techniques of public administration and management. For much of the 1990s, I was commissioned by numerous international agencies in research projects, lectures, reports and keynote addresses. My sustained association with the United Nations University in Tokyo called for many visits to that city and eventuated in two important coedited books with Fu-chen Lo on world cities and globalization published by the United Nations University Press in 1996 and 1998. Finally, the Institute cooperated, in 2001-2003, with the Hong Kong Housing Authority in a research project to review and appraise fifty years of public housing in Hong Kong. A book bearing that name was subsequently published by The Chinese University Press.

A measure of the success or otherwise of a research institute is the quality and quantity of its publications. While quality is for other people to pass judgment on, we have succeeded in distinguishing ourselves as the most active publishing unit on campus after the CU Press. To date, we have published 71 monographs, 190 occasional papers, in addition to many other scholarly books published by the CU and other universities presses abroad. In addition, the Institute has been responsible for producing several series of publications arising from the work of the Shanghai-Hong Kong Development Institute, a joint research set-up since 2001 between this university and Fudan University in Shanghai. I have doubled up from the outset as this Institute's Director and overseen its administrative and publication needs.

Since the establishment of the Institute in 1990, strong links have been established between the government and ourselves. That Lau Siu-kai was tapped to lead the Central Policy Unit is probably the most telling evidence of how favourably the government has viewed the quality of our research. In addition, Liu Pak-wai, Sung Yung-wing and I have been appointed to many government or quasi-government committees, at which we have made our contributions to policy-making and socio-economic development in Hong Kong. In recognition of our contributions in this regard, Liu Pai-wai have been awarded SBS and JP, and I was conferred SBS, OBE and JP.

Moving on to review the progress of the past year, the most important event for Hong Kong is, of course, a series of activities leading up to the tenth anniversary of the establishment of HKSAR in July 2007. With the election of Donald Tsang as the Chief Executive of the third HKSAR government, the second decade of Hong Kong as an SAR began in that month. As a university contribution to the HKSAR recognized events for this milestone, the Institute was invited by the Vice-Chancellor to organize an international conference on the HKSAR at Ten held on campus on 18 June 2007. A book arising from the papers read at the conference is at the final stages of preparation for publication by the CU Press. The book is anticipated to appear in the near future.

Having just been established in July 2006, the past year also saw the Centre for Quality of Life as a new centre of research activity within the Institute. It has held its annual quality of life survey and the results were announced in a news release. Many activities are being planned for its longer future. Further details

of the activities of this research centre and other research centres/programmes can be found in the following pages.

The mention of quality of life brings to mind another related and important research activity that the Institute has been undertaking for the past three years for the Research Centre for Development Strategies of the Macao Sustainable government. As a joint project between our Institute and the Centre of Asian Studies at The University of Hong Kong, we launched the third phase of the Quality of Life Survey in April-May 2007, with the first round of surveys undertaken two years ago. This time, we were requested to undertake special studies apart from the Macao-wide survey, on population policy, social class and urban planning. The project is scheduled for completion in late 2007.

In January and September 2006, the Institute jointly organized the inaugural regional forums with the Hong Kong Commercial Daily, Asia TV, and Singtaonet focused, respectively, on Western Guangdong, and Northern/Eastern Guangdong, highlighting cooperation between these respective sub-regions and Hong Kong/Macao. Both forums attracted a large turnout of key government officials, scholars, entrepreneurs and media representatives. Both forums have resulted in a book each, the earlier one published by the Institute. A continuation of these forums is in the works, as the responses to the high-profile gatherings were enthusiastic and very positive.

With regard to line functions, we have had another bountiful year in publication. Three monographs have appeared, but a total of 17 occasional papers have been published, way exceeding our nominal standard of one occasional paper every month. In external liaison, the Institute has received 90 scholars from the mainland and overseas, held 11 seminars, forums, conferences and press conferences. A total of 47 commissioned surveys were conducted by the Telephone Survey Research Laboratory, making a cumulative total of over 660 commissioned surveys since its founding in May 1995. The reorganization of our Documentation Unit is near completion. The ambitious project of digitizing our Hong Kong newspaper collection of 450,000 clippings since 1998 is almost complete, after the latest round of financial assistance from the Lee Hysan Foundation. It is anticipated that this project will be completed before the end of 2007, when active redeployment of the relevant clerical staff will follow.

I wish to conclude this message with a genuine expression of appreciation and thanks to my colleagues at the Institute who have grown and mellowed with me as it is about to complete its adolescence and enter a youthful stage. The staunch support by the University at different levels and from different directions has also contributed to the Institute's continued vitality and growth. The community support we have received over the years from the government, donors and friends has likewise given us the energy and drive to innovate and search for research excellence. I am leaving my directorship to more youthful leadership in a comfortable frame of mind, knowing that the Institute will continue to grow from strength to strength. In any event, I shall remain, at least for the coming year, as Research Professor and Co-Director of the Urban and Regional Development in Pacific Asia Programme. I am confident that under new leadership, the Institute will enter another period of renewed growth and wider participation and, in the process, scale another rung in the progress for further recognition and success.

PROFILES OF THE SENIOR STAFF

Prof. Yeung Yue-man 楊汝萬

With basic training in geography in Hong Kong, Canada and the United States, Prof. Yeung has had a rich and varied career that has spanned teaching, research, international development and university administration. He had been away from Hong Kong for almost two decades, studying in North America and working in Singapore and Canada, before being appointed Chair Professor of Geography at this University in 1984. Prof. Yeung has travelled to most countries in the Asia-Pacific region and has worked with many Asian research institutes and researchers. His research interests lie mainly in Asian cities, low-cost housing and policy studies and design for development, with particular reference to Pacific Asia. He has published numerous books and articles in international learned journals on these subjects. Apart from being the Director of the Institute, Prof. Yeung leads the Urban and Regional Development in Pacific Asia Research Programme. Prof. Yeung plays a very active role in serving the Hong Kong community through memberships in several public bodies providing key urban services, and he participates collaboratively in many regional and global research projects.

Prof. Sung Yun-wing 宋恩榮

Prof. Sung is currently Professor and Chairman of the Economics Department of the Chinese University of Hong Kong. He is Director of Institute of Economics, Associate Director of the Hong Kong Institute of Asia-Pacific Studies, and also Co-Director of the Hong Kong and Asia-Pacific Economies Research Programme of the same Institute at the Chinese University of Hong Kong. He is Editor of the *Asian Economic Journal* (2001- present), Corresponding Editor (Hong Kong) of the *Asian-Pacific Economic Literature* (1987-present), member of the Editorial Board of *The*

China Review (2000-present), and member of the Academic Committee of China Economic Journal. He is a member of the Board of the Hong Kong and Macau Research Centre of the Shanghai Academy of Social Sciences, the Social Sciences Advisory Board of Lingnan University (2002-08), and Academic the Research Base on the International of Committee Competitiveness of the Chinese Economy of the Fudan University. In public service, he is Governor of the Savantas Policy Institute, and a member of the CPU Panel on Pan-Pearl (2005-present), the Economic Development Delta Committee of the Business Professional Federation, and the Hong Kong Committee for Pacific Economic Cooperation (HKCPEC). His research interests include international trade, economic development, the Hong Kong economy, and the Chinese economy

Prof. Fanny M. Cheung 張妙清

Prof. Cheung, Ph.D. (Minnesota), Director of the Gender Research Centre, established the Gender Research Programme at CUHK in 1985. When she was Dean of the Faculty of Social Science in 1995-1996, she initiated the Gender Studies Programme. An active advocate for women's development in the community and a recognized women's leader in the Asia-Pacific region, she served as the founding chairperson of Hong Kong's Equal Opportunities Commission from 1996-1999. Her research interests in gender issues include gender roles, violence against women, women's leadership and gender equality. Other research interests in psychology include personality assessment and cross-cultural psychopathology.

Prof. Chiu Wing-kai, Stephen 趙永佳

Prof. Chiu got his doctorate from Princeton University and is currently Professor in the Sociology Department, the Chinese University of Hong Kong and Associate Dean, Faculty of Social

Science, The Chinese University of Hong Kong. His research interests include development studies, industrial relations, social movements and the comparative study of the East Asian Newly Industrialized Economies. He has published widely international journals and has also written two co-authored books: East Asia and the World Economy (1995, Newbury Park: Sage) and City-States in the Global Economy: The Industrial Restructuring of Hong Kong and Singapore (1997, Boulder: Westview). His recent publication includes an co-edited volume in 2000, The Dynamics of Social Movement in Hong Kong (Hong Kong: University of Hong Kong Press). He is also concurrently serving as the Deputy Chair of Social and Economic Policy Institute, a think-tank serving grassroots labour organizations in Hong Kong. Active in the Liberal Studies community in the secondary school sector, he has been the coordinator of the Support Programme on the Teaching and Learning of Liberal Studies, Sociology Department, the Chinese University of Hong Kong since its inception in 1997 and is also a member of the CDC-HKEAA Committee on Liberal Studies (Senior Secondary). He has also served as the Part-time Member of the Central Policy Unit, HKSAR Government, and as a member of the Strategic Development Commission, HKSAR Government.

Prof. Kuan Hsin-chi 關信基

Prof. Kuan, Director of the South China Programme, is Academician of the Pontifical Academy of Social Sciences, Vatican. He is also Emeritus Professor of Government and Public Administration of the Chinese University of Hong Kong and the Director of its Universities Service Centre for China Studies. He has co-authored The Ethos of the Hong Kong Chinese and co-edited the first two volumes of China Review and China Review 1992, as well as China Review 1997. He has contributed to The China Quarterly, Journal of Contemporary China, Studies in Comparative Communism, Asian Survey, Journal of . Comparative Commonwealth Studies, Pacific Affairs, and Electoral Studies.

Prof. Kwan Cheuk-chiu, Andy 關焯照

Prof. Kwan is currently Associate Professor of the Economics Department of the Chinese University of Hong Kong. He is Associate Director of the Centre for Quality of Life which was established in 2006. Prof. Kwan is one of the authoritative researchers in the field of consumer confidence. He is in charge of the Quarterly Survey of Consumer Sentiment which aims to provide policy makers, economists and business managers with important and timely information on the short-term economic trend of Hong Kong. In public service, he was a member of the Business and Professionals Federation of Hong Kong (1998-1999) and a member of the Public Policy Forum (2005-2006). He is frequently interviewed by local and foreign press on economic issues.

Prof. Lau Siu-kai 劉兆佳

Prof. Lau graduated from the University of Hong Kong in 1971 with a BSocSc degree in sociology and economics, and from the University of Minnesota in 1975 with a Ph.D. in sociology. He joined CUHK in 1975. His major research interests are comparative political and social development, society and politics in Hong Kong, and political development in traditional and modern China. He tackles both macroscopic and microscopic issues, such as political culture and political behaviour. His favourite approach is the comparative historical method. His publications include Society and Politics in Hong Kong (1982) and, with Prof. Kuan Hsin-chi, The Ethos of the Hong Kong Chinese (1988).

Prof. Liu Pak-wai 廖柏偉

Prof. Liu is currently Professor in Economics, Pro-Vice Chancellor of the Chinese University of Hong Kong, and Director of the Hong Kong and Asia-Pacific Economies Research Programme at the

Chinese University of Hong Kong. He is Director of the EAEA (1997-2002, 2005-present), and member of Management Committee of Hong Kong Institute of Economic and Business Strategy (2002present). In public service, he serves as Director of the Hong Kong Institute for Monetary Research (2003-present), and Non-Executive Director of Securities and Futures Commission (2005-present). He is a member of a number of advisory committees, including Manpower Development Committee (2002-present), Independent Commission on Remuneration for Members of the Executive Council and the Legislative Council of the HKSAR (2003-present), Aviation Development Advisory Committee (2005-present) and Commission on Strategic Development (2005-present). His research interests cover the areas of applied theory, labour market and employment, and the Hong Kong economy. Besides a continuing interest in economic theory, Professor Liu is interested in the empirical aspects of economics.

Prof. Shek Tan-lei Daniel 石丹理

Daniel T. L. Shek (PhD., FHKPS, BBS, JP) is Professor in the Department of Social Work at The Chinese University of Hong Kong. He is Director of the Centre for Quality of Life, Hong Kong Institute of Asia-Pacific Studies and Associate Director of Social Welfare Practice and Research Centre, The Chinese University of Hong Kong. He is Honorary Professor of Kiang Wu Nursing College of Macau and Fellow of the Hong Kong Psychological Society. Daniel Shek is Chief Editor of Journal of Youth Studies, Consulting Editor of Journal of Clinical Psychology, an international consultant of American Journal of Family Therapy, and a member of the editorial boards of several international refereed journals, including Social Indicators Research, International Journal of Adolescent Medicine and Health, Child Health and Human Development, International Journal on Disability and Human Development, and Asian Journal of Counseling. He has to date published 27 books, 58 book chapters, and more than 180 articles in international refereed journals. He has served in many government advisory bodies,

including Action Committee against Narcotics, Commission on Youth, Fight Crime Committee, Women's Commission, and Independent Police Complaints Council.

Prof. Shen Jianfa 沈建法

Prof. Shen is Professor and Head of Graduate Division in the Department of Geography and Resource Management. He is also Co-director of Urban and Regional Development in Pacific Asia Program of the Institute. He is a member of the Steering Committee of the Commission on Population and Vulnerability, International Geographical Union and an executive member of the Editorial Board of China Review: An Interdisciplinary Journal on Greater China. He also serves in the Editorial Boards of Population, Space and Place, GeoJournal: An International Journal on Geography, Applied Spatial Analysis and Policy and Journal of Subtropical Environment and Resources. He obtained his PhD degree in Geography from the London School of Economics in 1994. His research interests focus on migration, urbanization, urban and regional development/ governance in China. He is the co-editor of China Review 2000 (2000), Resource Management, Urbanization and Governance in Hong Kong and the Zhujiang Delta (2002) and Developing China's West (2004). He has contributed to many international journals such as The Professional Geographer, Urban Geography, Geoforum, Environment and Planning A, Geographical Iournal, Population, Space and Place, Habitat International, Progress in Planning.

Prof. Simon X.H. Shen 沈旭暉

Prof. Shen is currently a Research Assistant Professor of the Chinese University of Hong Kong's Institute of Asia-Pacific He received his DPhil degree in politics international relations from University of Oxford, and a joint MA (political science) and BA (political science and history) degree from Yale University. Contributed to journals such as Pacific

Review, Asian Perspective, East Asia, Journal of Chinese Political Science and Journal of East Asian History, Shen's research interests include Sino-US relations, Chinese nationalism, anti-terrorism, external relations of Hong Kong and globalization. He is also the founder of the Roundtable Social Science Research Network in Hong Kong.

Ms. Wan Po-san 尹寶珊

Ms Wan received her BSSc and MPhil in sociology from CUHK. She is experienced in conducting sample surveys and in research in the field of Hong Kong studies. Her major research interests are the status of women and the state of the environment. Other interests include gender issues, the quality of life, social problems, and patterns of social change in Hong Kong. She is responsible for the Institute's publications and is Co-director of the Social Indicators and Social Development of Hong Kong Research Programme.

Prof. Timothy Ka-ying Wong 王家英

Timothy Ka-ying Wong is currently a Research Associate Professor and Associate Director of Public Policy Research Centre of the Hong Kong Institute of Asia-Pacific Studies at The Chinese University of Hong Kong. Professor Wong's major research interests include social and political development in Taiwan and Hong Kong. He has contributed to such academic journals as Nations and Nationalism, Journal of Contemporary China, Asian Perspective, Social Development Issues, Democratization, Social Policy and Society, International Journal of Social Welfare, and Social Indicators Research

Prof. Yip Hon-ming 葉漢明

Prof. Yip (Ph.D., University of California, Los Angeles), Associate Director of the Gender Research Centre, has published on gender/women's history, the history of the overseas Chinese, modern and contemporary Chinese socio-economic history, and the local history of China and Hong Kong. As a member of the Association for the Advancement of Feminism, the Hong Kong Women Christian Council and other community organizations, she considers the coordination of teaching, research and social practice her greatest challenges at present. Taking power in history as her focal point of reflection in recent years, she is interested in exploring the historical contexts of developments and changes in the operation of power in human society. She is also interested in ways of exposing the historical roots of human manipulation and resistance in daily life. Related issues include marginalization and subordination, and subversion and struggle in the fields of gender, class and ethnicity.

Prof. Yu Xingzhong 於興中

Prof. Yu obtained a BA in English Literature from Lanzhou University in China, and an LLM (Master of Laws) and SJD (Doctor of Juridical Science) from the Harvard Law School. He teaches Chinese law, constitutional law and jurisprudence at the School of Law. He has been the Director of the Chinese Law Programme since March 2003. He has previously served as a Lecturer on law at the Harvard Law School (September-December 1999), a Senior Research Fellow in East Asian Legal Studies, Harvard Law School (1998-1999), a Visiting Professor at Beijing University's Department of Law (Spring 1998) and as an Associate (Chinese Legal Specialist) with the Chicago office of Baker & McKenzie (November 1995 - February 1998). He was also a Visiting Scholar at Columbia Law School (1988-1990) and a Visiting Fellow at the Australian National University (1984-1986). His research interests include social and political theory, cultural studies of law, jurisprudence, constitutional and administrative law, constitutionalism in Hong Kong and China, comparative law, Chinese legal history, and PRC law. He has contributed to various journals and book projects.

Objectives

The Programme was designed to promote scholarly research on issues of quality of life in the world in general and Hong Kong in particular through cross-disciplinary research, exchange activities, and cross-institutional collaboration. Besides, the Centre is committed to produce knowledge on quality of life contributes social service development, to formulations and promotion of the quality of life of people in Hong Kong.

Research Activities

The major research activity of the Centre during the year was to update the CUHK Hong Kong Quality of Life Index (QoL Index). Incorporating the effort and expertise of faculty members from different disciplines, the Faculty of Social Science has compiled a

composite index named "CUHK Hong Kong Quality of Life Index" (QoL Index) since 2002. Starting from the year of 2003, the Index is updated and released annually.

The QOL Index is developed to address the following objectives:

- To measure and monitor the quality of life in Hong Kong (1)in the 21st century;
- (2) To engage relevant parties in promoting the quality of life in Hong Kong;
- To provide policy-makers and the community with useful (3) statistics on the quality of life in Hong Kong; and
- **(4)** To advocate the quality of life in Hong Kong and draw public attention to the issue of quality of life.

The Hong Kong Quality of Life Index is a composite index. It consists of 21 indicators that are grouped into three subgroups, including Social, Economic and Environmental sub-indexes. Among the 21 indicators, six are compiled by the Faculty of Social Science, based on data collected by surveys conducted by the Hong Kong Institute of Asia-Pacific Studies of the University. These indicators are stress index, general life satisfaction index, press freedom index, press criticism index, government performance index and index of current economic conditions. All other indices are obtained from the government and related institutions.

A theme research comprising three sub-projects funded by the Direct Grant, Social Science Panel, The Chinese University of Hong Kong was conducted to collect the data for the CUHK Quality of Life Index 2006. The sub-projects included: a) CUHK Hong Kong Quality of Life Index - Socio-Cultural Sub-index; b) CUHK Hong Kong Quality of Life Index - Economic Sub-index; and c) CUHK Hong Kong Quality of Life Index - Environmental Sub-index.

The Gender Research Centre, which was founded as the Gender Research Programme in 1985, is the first research unit on gender and women's issues in Hong Kong. Our mission is to promote knowledge in gender research and women's status. Given the interdisciplinary nature of gender research, members include scholars from Social Science, Humanities, Education, Medicine, Business Administration, and other interdisciplinary fields. Other faculty and staff of the university may join as members. Non-CUHK members and students may also join as affiliates.

International symposium and conference

International Conference "Women's Policy in China and Korea: Thinking from Women's Lives" was held from 24 May to 27 May 2007 at the Keimyung University, South Korea. The conference was co-organized by the Institute for Women's Studies (IWS) of Keimyung University, Korean Women's Development Institute (KWDI), Women's Studies Center of Peking University, Gender Research Centre (GRC) of CUHK, Gender Studies Programme (GRS) of CUHK and the Women's Studies Center of Yanbian University.

Strategic partnership agreement

The Gender Research Centre and the Gender Studies Programme, The Chinese University of Hong Kong, and the Institute for Women's Studies, Keimyung University, signed a memorandum of understanding on 24 May 2007 in South Korea, establishing

cooperative relations among the three units, especially with respect to developing academic and cultural exchanges in education and research in gender-related fields.

Asian Economic Journal and East Asian Economic Association

This is the seventeenth year in which our Programme has jointly published the Asian Economic Journal for the East Asian Economic Association with our partner in Japan. Since 1997, the number of issues published each year has been increased from three to four. Professors Liu Pak-wai and Kwong Kai Sun have served as the Secretary General of the East Asian Economic Association from 1997 to 2002, and from 2003 onwards respectively. Professors Sung Yun-Wing, and Chou Win-Lin have served as Managing Editor of the journal from 1997 to 2000, and 2003-2006 respectively. Professor Kwong Kai-Sun served as Managing Editor of the journal from 2000-2003, and also since 2006. Professor Sung Yun-Wing served as Editor of the Journal since 2001. Since 2005, Professor Liu Pak-Wai was elected Director of the EAEA, and Professor Lawrence Lau was elected President of the EAEA.

Asian Economic Journal is a journal that is devoted to publishing articles on the Asian economies which is based in the Asian region. The journal has a wide circulation not only in Asia but also in Europe and North America. Its readership is expected to increase as economists worldwide focus their attention on the economic successes and problems of the Asia Pacific region. Since 2004, all issues of the journal have been published on time and it is applying for inclusion in the Social Science Citation Index. The Editorial Committee is very broad-based. It includes leading economists from all major East and Southeast Asian countries. Because the journal is edited, printed and published at CUHK, it

bears the name of CUHK together with The International Centre for the Study of East Asian Development on the front cover as the two institutions which produce the journal. The Secretariat of the East Asian Economic Association is also located at CUHK using HKIAPS as its address. The journal and the location of the Secretariat have promoted the image of CUHK in general, and HKAPE and HKIAPS in particular as institutions active in research within the Asia-Pacific region.

Impact

As a result of their expertise, the Co-Directors of the programme have served in many public and professional advisory committees which are listed below. These professional activities, which are related to HKAPE, have an impact on the local community as well as the Asia-Pacific. They also help to project the image of the Research Programme.

Professor Liu Pak-Wai is Director of the EAEA, a member of Management Committee of Hong Kong Institute of Economic and Business Strategy, and an advisor of Bauhinia Foundation Research Centre. In public service, he serves as Director of the Hong Kong Institute for Monetary Research, and Non-Executive Director of Securities and Futures Commission. He is a member of many advisory including committees, Manpower Development Committee, Independent Commission on Remuneration for Members of the Executive Council and the Legislative Council of the HKSAR, Committee on Economic Co-operation with the Mainland of the Commission on Strategic Development, and Aviation Development Advisory Committee.

Professor Sung Yun-Wing is Editor of the Asian Economic Journal, Corresponding Editor (Hong Kong) of the Asian-Pacific Economic Literature, member of the Editorial Board of The China Review, and member of the Academic Committee of China Economic Journal. He is a member of the Board of the Hong Kong and Macau

Research centre of the Shanghai Academy of Social Sciences, the Social Sciences Advisory Board of Lingnan University, Academic of the Research Base on the Committee Competitiveness of the Chinese Economy of the Fudan University, Review Panel of two research centre of the University of Hong Kong, namely, Hong Kong Institute of Economics and Business Strategy (HKIEBS), and Asia-Pacific Economic Co-operation Study Centre (APEC Study Centre). In public service, he is Governor of the Savantas Policy Institute, and a member of the CPU Panel on the Pan-Pearl River Delta, the Economic Development Committee of the Business Professional Federation, and the Hong Kong Committee for Pacific Economic Cooperation (HKCPEC).



Objectives

The Public Policy Research Centre is an interdisciplinary research unit under The Hong Kong Institute of Asia-Pacific Studies. Working closely with the Social Science Faculty of the University, and also other faculties, centres and institutes, the Centre strives to promote public policy research on Hong Kong, the Pearl River Delta and also the Asia-Pacific region in general. To achieve this mission, the Centre endeavours to provide a platform for supporting and stimulating faculty members to carry out public policy research and to exchange their ideas and findings.

Working Groups

The Centre organizes its activities around multi-disciplinary working groups, each focusing on a major policy issue and under the purview of one coordinator. Currently four working groups have been formed. Themes and coordinators of these groups are:

1. Public Policy Education

Coordinator: Prof. Chiu Wing-kai, Stephen

2. Governance

Coordinator: Prof. Chan Kin-man

3. Social Policy

Coordinator: Prof. Wong Chack-kie

4. Mass Media

Coordinator: Prof. So Y. K., Clement

Forums and Conferences

To act as a bridge between the University and the wider community in the understanding and deliberation of policy issues, the Centre organizes policy forums, conferences and seminars through which scholars, practitioners, opinion leaders, government officials and other outside experts can share and exchange their views. Two public policy forums and an academic conference were organized in the last academic year and brief introductions of these activities are as follows:

Public Policy Forum on "Hong Kong Chinese Family Health" (January 2007):

The forum was jointly organized with the Social Work Department of The Chinese University of Hong Kong. Guest of honour who had joined the forum included Fung Pak-yan, Deputy Director (Services) of the Social Welfare Department and Christine Fang, Chief Executive of the Hong Kong Council of Social Service.

Public Policy Forum on "Child Trust Fund: Strategy for Implication and Commitment of All Circles" (June 2007):

It was also co-organized with the Social Work Department of our University. Legislator Fung Kin-kee, and some NGO leaders had joined the discussion to explore the possibilities to launch a Child Trust Fund in Hong Kong.

Conference on "The Role of the Government of Hong Kong" (November 2006):

To gain a better understanding of the changing role of the government in Hong Kong amid such changes as globalization and Hong Kong's increasing socio-economic integration with the Mainland, the Centre, the Central Policy Unit of the Hong Kong Government, and the Hong Kong Sociological Association had jointly organized an academic conference at the Cho Yiu Conference Hall. Professor Peter Evans, distinguished sociologist at the University of California, Berkeley, and seven eminent local scholars presented papers addressing various aspects of this important topic. Papers submitted to this conference will be included in a forthcoming book.

Press Conferences

In order to disseminate widely the research findings of our Centre to the general public and scholarly community and to raise public awareness of policy issues, two press conferences were held to publicize our survey findings. Topics and dates of these press conferences are as follows:

- "Hong Kong Chinese Family Health 2006" (December 2006)
- "Hong Kong Parents' Child Nurturance Attitudes and Preferences Survey" (June 2007)

Surveys

Three surveys were conducted to collect public opinion on family health, child care and social mobility respectively. Survey findings were publicized at relevant public policy forums and press conferences mentioned above.

Survey on "Hong Kong Chinese Family Health 2006" (November 2006):

The Centre commissioned the Telephone Survey Research Laboratory of our Institute to launch a telephone poll to study family relationships and related matters of Hong Kong people. Finally, 1,020 people were successfully interviewed, yielding a response rate of 52.7%.

Survey on "Hong Kong Parents' Child Nurturance Attitudes and Preferences" (April 2007):

It was the second telephone survey of our Centre that was done through the Telephone Survey Research Laboratory in the last academic year. This time we have got 706 successful and the response rate was 75.9%.

In collaboration with the Telephone Survey Research Laboratory and the Social Indicators Programme of the Institute, the Centre was commissioned by Prof. Lui Tai-lok of the Sociology Department to conduct a household survey to study the social mobility of Hong Kong people. Fieldwork of this territory-wide survey was started in May 2006 and was finally completed in January 2007. Nearly 1,800 Hong Kong people were successfully interviewed.

Research Grants

"A Study on Social Enterprises in Comparative Perspective" by Prof. Chiu Wing-kai and Prof. Wong Ka-ying:

This research project was commissioned by the Central Policy Unit of the Hong Kong Government. It aimed to compare the development of social enterprises in different countries and saw how relevant their experiences were to Hong Kong. The project was divided into two stages. The first stage involved a descriptive overview of social enterprise development in the US, the UK, Italy, Sweden and Taiwan within a comparative framework inspired by the welfare regime literature. The second stage involved more in-depth, theory-driven comparison of how social contexts vary to affect (1) the scale and scope of social enterprise development and (2) the level of success of social enterprise development. The final report of this research project was submitted to the government in October 2006.

"Developing Curriculum Materials for Liberal (Advanced Supplementary Level): Basic Law and Legal System in Hong Kong" by Prof. Chiu Wing-kai:

Funded by the Education and Manpower Bureau, this project targeted to develop curriculum materials for the unit "Basic Law and Legal System in Hong Kong" that is part of the existing Liberal Studies (Advanced Supplementary Level) curriculum and will also be part of New Senior Secondary Liberal Studies. Main jobs of the project included collection of relevant web links and references, identification of relevant concepts, developing of fact sheets and lesson plans, organization of workshops and compilation of a summary report. The project was completed in April 2007.

"Develop Learning and Teaching Resources for New Senior Secondary (NSS) Liberal Studies: Module 3 (Modern China) & Module 4 (Globalization)" by Prof. Chiu Wing-kai:

The purpose of this project is to develop resource support for New Senior Secondary Liberal Studies Curriculum with special focus on Module 3 (Modern China) and Module 4 (Globalization). Its main tasks are to identify some relevant concepts that are essential to the study of the two Modules, to develop fact sheets and lesson plans, to organize workshops and to compile a summary report. The project was also commissioned by the Education and Manpower Bureau and is expected to be completed in September 2007.

"A Study on a Cross-National Comparison of Family Policy" by Prof. Chiu Wing-kai:

This research study is funded by the Central Policy Unit of the Hong Kong Government. Using a typology of family policy developed by Gauthier A. H., this study intends to explain the impact of social and demographic changes in the last several

decades on the choice of policy measures and instruments for implementing family policy in France, Germany, Sweden, Britain and Singapore. Through the discussion of family policy in these countries, this study will lead to the development of an analytical framework to understand and compare family policies in different countries and regions. By studying and comparing the family policies of the above countries, this research will also aim at finding what Hong Kong can learn from their experiences. A final report of the study is planned to submit to the Government in early 2008.

Study Tour

During the past year, the Centre had organised two study tours in December 2006 and in July 2007 for the post-graduate students from Taiwan. Professors from local tertiary institutions were invited to give lectures to the participants. Topics covered ranged from the political reforms to the challenge of Hong Kong economy. Both tours were sponsored by the Hong Kong and Macau Association.

Social Indicators and Social Development of Hong Kong

Programme Directors: Prof. Lau Siu-kai (on leave)

Objectives

The Programme focuses on measuring and studying social developments in Hong Kong. Its prime purpose is to build up a comprehensive system of social indicators, i.e., a set of longitudinal data on the subjective and objective dimensions of social conditions and social changes, for Hong Kong. It is hoped that the availability of such data will facilitate not only analyses of patterns of social change and explorations of social issues and problems but also contribute to the evaluation and formulation of public policy.

Conferences

"2006 Conference on Social Image and Social Indicators: Hong Kong and Taiwan"

This conference was organized in collaboration with the Institute of Sociology of the Academia Sinica, the Centre of Asian Studies of the University of Hong Kong, and the Department of Applied Social Sciences of the Hong Kong Polytechnic University. It was held on 1-2 September 2006 at the Academia Sinica in Taipei. Eleven papers were presented. A conference proceeding is expected to be published by the end of 2007.

"The Fifth Conference on Social Indicators Studies in Chinese Societies"

This conference was organized jointly with the Centre of Asian

Studies of the University of Hong Kong and the Department of Applied Social Sciences of the Hong Kong Polytechnic University. It was held on 8-9 December 2006 at the Hong Kong Polytechnic University. Its major objectives are to provide a forum for intellectual exchange on social indicators studies, to consolidate research experiences, to promote this line of research in Chinese communities, as well as to serve as the basis for further exchange and collaboration. Nineteen papers were presented by scholars from mainland China, Taiwan, Macao, and Hong Kong. A conference proceeding is expected to be published by October 2007.

Research Activities

Highlights of the main activities during the past year are underlined as follows:

"Social Indicators Survey Series" coordinated by Prof. Lau Siukai and Ms Wan Po-san

The Programme has been conducting a series of biennial territory-wide household surveys since 1988. These periodic surveys aim to measure the scope and extent of significant aspects of social change in Hong Kong by focusing on the perceptions, values, feelings, aspirations, and sense of well-being of the Hong Kong people on various important aspects of their daily lives.

The survey "Hong Kong as a Risk Society: Indicators of Social Development in Hong Kong 2005," is funded by a Competitive Earmarked Research Grant (HK\$1,635,200) from the Research Grants Council, and is being conducted in collaboration with the Centre of Asian Studies of the University of Hong Kong and the Department of Applied Social Sciences of the Hong Kong Polytechnic University. The members of the CUHK team include Prof. Kuan Hsin-chi, Prof. Lau Siu-kai, Prof. Kenneth W. K. Law

(Lingnan University), Prof. Simon T. M. Ng (Open University of Hong Kong), Prof. Benny Y. T. Tai (University of Hong Kong), Ms Wan Po-san, and Prof. Timothy K. Y. Wong. Special topics in this survey include: (1) family and marriage; (2) social risk; (3) political attitudes and the welfare state; and (4) legal attitudes and retirement. The collection and processing of survey information were completed. A general report is anticipated to be published by the end of 2007.

In addition to the household survey, a series of topical polls was launched in 2004 to take the pulse of the society and to provide timely information on new developments falling outside of the regular trend series. Two telephone polls, one on the development of Hong Kong and mainland China and another on civic awareness and civic education, were completed in October 2006 and March 2007, respectively.

"A Comparative Study of the Social Image of Taiwan and Hong Kong"

This project is being conducted in collaboration with the Institute of Sociology of the Academia Sinica, the Centre of Asian Studies of the University of Hong Kong, and the Department of Applied Social Sciences of the Hong Kong Polytechnic University. A telephone survey will be conducted once or twice a year to gauge the perceptions, values, and subjective well-being of the people of both societies. The core questions of the questionnaire will be kept unchanged as far as possible in order to detect social trends and changes, while questions on special topics will be flexible enough to reflect changes in social conditions. The eighth survey,

which focused on subjective well-being, socio-political trust, and social problems, was carried out in December 2006.

"An Exploratory Study of Public Opinions on the Impact of the Comprehensive Social Security Scheme in Hong Kong" by Prof. Wong Chack-kie (Principal Investigator), Prof. Tang Kwongleung and Prof. Wong Hung

This study aimed to identify subjective indicators of public opinion on the impact of the social policy on poverty alleviation and employment promotion. Identifying these indicators will help policy makers to determine whether the policy is effective, on the basis of public perceptions, in achieving the intended consequences. The study was partly funded by Mr Richard Liu. A Telephone poll was conducted in May 2005. A manuscript entitled "Knowledge of Public Policy and Perceived Impact of the Welfare Benefits System" was submitted for review.

"Gender Socialization in Hong Kong's Primary Sector Education" by Prof. Kenneth W.K. Law (Principal Investigator), Prof. Annie H.N. Chan (Lingnan University, Principal Investigator) and Ms Wan Po-san

This project is funded by the Quality Education Fund. This study aims: (1) to establish a set of baseline measures regarding the current state of gender socialization in Hong Kong's primary schools; (2) to examine the context and processes of gender socialization in primary education; and (3) to address some of the theoretical issues that have arisen out of the academic literature on gender in the schooling process. A variety of methods, including a student survey on gender role attitudes, focus group interviews with primary school teachers and students, classroom observations, a survey on the participation of primary school students in extra-curricular activities, and a content analysis of primary school textbooks, are being used to collect data.

"Macao Population Policy Research Project"

The study is commissioned by the Research Centre for Sustainable Development Strategies of the Government of Macao Special Administrative Region and is being conducted in collaboration with the Centre of Asian Studies of the University of Hong Kong. The members of the CUHK team include Prof. Yeung Yue-man, Prof. Shen Jianfa, Prof. Timothy K. Y. Wong, and Ms Wan Po-san. Six focus group interviews were conducted in May 2007 and a telephone survey will be launched in August. The project is scheduled to be completed in November 2007.

"The Quality of Family Life in Hong Kong in the Past 20 Years" by Ms Wan Po-san and Prof. Timothy K.Y. Wong

The study was commissioned by the Central Policy Unit of the Government of the Hong Kong Special Administrative Region. It aimed to identify and analyse trends and patterns in Hong Kong people's satisfaction with family life, based on data collected from the Hong Kong social indicators surveys between 1988 and 2006. The final report was submitted in April 2007.

"The Second Phase Study on the Quality of Life in Macao 2006"

The study was commissioned by the Research Centre for Sustainable Development Strategies of the Government of Macao Region and conducted in was Administrative Special collaboration with the Centre of Asian Studies of the University of Hong Kong. The members of the CUHK team included Prof. Yeung Yue-man, Prof. Chan Ying-keung, Prof. Timothy K. Y. Wong, and Ms Wan Po-san. Five telephone surveys, a mail questionnaire survey, and focus group interviews conducted. The final report was submitted in January 2007.

"The Third Phase Study on the Quality of Life in Macao 2007"

The study is commissioned by the Research Centre for Sustainable Development Strategies of the Government of Macao Special Administrative Region and is being conducted in collaboration with the Centre of Asian Studies of the University of Hong Kong. The members of the CUHK team include Prof. Yeung Yue-man, Prof. Chan Ying-keung, Prof. Timothy K. Y. Wong, and Ms Wan Po-san. A territory-wide household survey was conducted in April-May 2007. South China

Programme Director: Prof. Kuan Hsin-chi

Objectives

The principal aim of the Programme is to encourage faculty research related to contemporary China studies awarding research grants. From the very beginning, welcomes inter-disciplinary cooperation research partnership with units across the border. There is no limitation as to the discipline or topics, while a study that focuses on or related to the region of South China is preferred in principle. In recent years, greater emphasis has been placed on the development of in-house team projects, apart from the support given to projects undertaken by individual faculty members. In terms of intellectual orientation, the Programme continues to favour research problems related to the withering of outdated systems and the evolution of new institutions and practices in the economic, social, mass media and political arena. Most recently, the Programme began to support development of databases and organization of conferences.

Executive Committee

Prof. H.C. Kuan continued to serve as the convener. Members included Prof. Y.M. Yeung, Prof. C.C. Lau and Prof. K.Y. Tsui.

Research Activities by Individual Faculty

Two individual projects were still going on:

1. Lin Hui, Institute of Space and Earth Information Science, "GIS-based Near Real-time InSAR Method for Monitoring Slope Movement." This research deals with the computation methods with a view to improving the production of the InSAR analysis results in near real time domain, i.e. within 12 hours of computation. This would address the bottlenecks of the current methods and enhance the optimal use of the radar data received by the CUHK Satellite Remote Sensing Receiving Station.

- 2. Simon Shen, Hong Kong Institute of Asia-Pacific Studies, "External Relations of Hong Kong and South China." This research has three major themes. First, it studies the way in which globalization interacts with the nature and changing patterns of provincial government engagement in external relations with reference to South China. Secondly, the Hong Kong policy of major countries in the world and their interactions with local entities in town will be examined. Thirdly, the investigator is interested in the normative orientations and values on the position of Hong Kong vis-àvis South China.
 - A. This project had during the year organized a Seminar Series: New World Order(s), New World View(s): Sino-US Relations in collaboration with the Institute of Asia-Pacific Studies, CUHK, Roundtable Community and the U.S. Consulate General in HK. Topics included
 - 1. Balancing Progress and Preservation: The U.S. Experience of Sustainable Development, 22 June 2007;
 - 2. Human Rights Report of the United States: Issues, Agenda and its Repercussion, 1 June 2007;
 - 3. An American Perspective on Iraq and its Possible Future, 12 April 2007; and
 - 4. American Views on the Rise of China, 29 January 2007.

B. A one-day conference "Hong Kong's Global Identity and Its Role in China's Bilateral Relations" was held on 25 June 2007.

During the year, two faculty members were awarded with research grants to support their projects. The details are as follows: --

- Mr. Simon Shen, Research Assistant Professor, the Hong Kong Institute of Asia-Pacific Studies, "Beyond Anti-Terrorism: How China is Constructing a Global Identity as a Responsible State in the Era of Anti-terrorism". The principal investigator is interested in the construction of China's national identity as a "responsible state" after 9-11. He would trace the origins of the tactics used and Further analyze the notable examples. questions would be addressed, such as whether the "peaceful rise" discourse represents an attempt to tone down the Chinese realist agenda to the Western audience. If so, how? Besides, does the same discourse serve the purpose of pacifying domestic nationalist dissent? The project is theoretically grounded in constructivism, neo-realism and contemporary nationalism, as applied to the study of foreign policies. The expected deliverable is a book.
- 2. Professor HA Keloon Louis (principal investigator), Centre for Catholic Studies, Department of Cultural and Religious Studies, and Professor KANG Zhijie (coinvestigator), Department of Political Science, Hubei University, "The Catholic Virgins". Despite their important contributions, the Catholic Virgins as a unique female group have been a neglected area of study by both academics and the Church. The proposed research will focus on Guangdong (especially the Lingnan area), Hong Kong and Macau and cover the life of the Catholic virgins, their relations with the local

church, the virgins as evangelists and superiors, and a comparative study of the Catholic virgins vis-á-vis the sisters and the virgins in general.

Group Research Project on Civil Society

The Project was formed in 2002 to replace "the Comparative Study of Civil Organizations in Chinese Societies." Prof. K.M. Chan from the Department of Sociology served as the convener of the project. Members included Prof. H.C. Kuan and Prof. S.G. Wang of the Department of Government and Public Administration, Prof. Lui Tai-lok from the Department of Sociology, and Prof. Joseph Man Chan from the School of Journalism and Communication. The project aims at promoting study on civil society in mainland China, Taiwan and Hong Kong, with an emphasis on Guangdong in its current phase of development.

The project at first worked closely with the Research Institute on Guangdong Development at Changsha University in Guangzhou. A Research Centre for NGOs in South China was jointly established in 2003 but was renamed as the Institute for Civil Society (ICS) in 2005. Besides conducting research on civil society, ICS now also provides capacity building courses to NGOs and promotes social innovation by publishing the Minjian magazine, establishing local foundations and providing seed money to newly established NGOs. Funding source of ICS includes Rockefeller Brothers Foundation, Oxfam, Community Partnership and other local donors.

Institute for Civil Society (ICS) has recently changed its name to Institute for Civil Society (ICS) under Department of Anthropology in the same university. Prof. Chan Kin Man (Sociology, CUHK) serves as the chair of its board of directors. Together with Department of Sociology in CUHK, ICS held a regional conference in June 2007 to discuss the relationships between civil society, government and business. More than 120

scholars and practitioners from Mainland, Taiwan and Hong Kong attended the conference.

Group Research Project on Greater China (the Trilateral Studies) within the "Asian Barometer"

Towards the end of the report year, the Programme decided to establish a research team to participate in the Asian Barometer. The focus is on public opinion on political values, democracy, and governance in Greater China, the main theme of the said Barometer. Dr. WONG Ka-ying Timothy, Research Associate Professor, Hong Kong Institute of Asia-Pacific Studies, serves as the convenor of the Team, with Prof. CHAN Kin-man, Department of Sociology, Prof. MA Ngok, Department of Government and Public Administration, and Prof. KUAN Hsinchi as members. A mass survey was being planned for execution in the fall of the academic year.

The Asian Barometer (ABS) is an applied research program on values, democracy, and governance around the region. The regional network encompasses research teams from 11 East Asian political systems and 5 South Asian countries. Together, this regional survey network covers virtually all major political systems in the region, systems that have experienced different trajectories of regime evolution and are currently at different stages of political transition. The mission and task of each national research team are to administer survey instruments to compile the required micro-level data under a common research framework and research methodology to ensure that the data is reliable and comparable on the issues of citizens' attitudes and values toward politics, power, reform, and democracy in Asia.

Graduate Seminar on China

Since 2005, the Programme had sponsored an annual seminar on China in early January under the auspice of the Universities

Service Centre for China Studies of the Chinese University. The purpose of the seminar is to provide advanced-level PhD students in China studies a platform for the participants to present their thesis research findings, to conduct intellectual dialogue with other participants and local scholars, and to carry out research at the Centre before or after the seminar.

Since the said Centre has secured alternative funding for the 2007 Graduate Seminar, the annual awarded was directed to enable the Centre to undertake a new initiative of data collection titled "Project of Folk History". The project has two components: the archive and the website. The archive will be a depository for memoirs and other non-fiction writings by common citizens. The website will be a window of the project which, hopefully, could help to make the collection known among the mainland memoirwriters and to arouse the interest in writing about personal experiences with the changing society in China among the public. Ms. Lin Da, a famous writer, will be the editor of the website.

Research Activities

The programme has been active along both fronts – urban and regional development – locally and internationally.

In terms of Chinese regional development research, the programme first published a monograph by the Institute highlighting infrastructure development within the Pan-Pearl River Delta, cumulating two years of research in this field. Second, another series of research on the relationship between Hong Kong and the Pan-Pearl River Delta under the 11th Fiveyear Plan has been launched. Two occasional papers in the new research series have been published. Third, the research project commissioned by the Bauhinia Foundation on the opportunities and challenges of Hong Kong under the 11th Five-year plan has been completed, with the report released in November 2006. The project was undertaken by Yeung Yue-man, Shen Jianfa and Zhang Li, with a grant of \$400,000. Fourth, the programme has been active in research on Northern, Eastern and Western Guangdong through two joint forums that were held in January and September in 2006 in Zhuhai and Huizhou, respectively. These were inaugural forums and are anticipated to be followed up by more forums in the future. Finally, the fifth book in a series of China's regional studies, this time on the Pan-Pearl River Delta, has been completed in March 2007. The manuscript is under review by The Chinese University Press for publication.

On the urban front, the Programme continued to collaborate

with the Chinese Academy of Social Sciences on the 2007 China Urban Competitiveness Study (Hong Kong). A Press Conference was co-organized between them, along with the Better Hong Kong Foundation in Hong Kong, on 28 March 2007. The programme received a number of invitations for research contribution. Yeung was invited to contribute an entry on "megacities" to the International Encyclopedia of Human Geography, and an article on urban Vietnam in Eurasian Geography and Economics. In addition, Yeung and Shen were invited to contribute a chapter on urban China and Vietnam in the International Handbook on Urban Policy, edited by H. S. Geyer. As preparation for the World Bank's World Development Report 2009, on the theme of spatial dimension of development, Yeung and Shen have been invited to contribute a background paper to summarize China's experience of rapid economic growth focused on its coastal cities. Earlier, Yeung contributed a similar paper to the themed Report 2000, on the subject of urban poverty in Pacific Asia.

Objectives

With China's resumption of sovereignty over Hong Kong on 1 July 1997 and the increasing economic and cultural exchange, epitomized in the CEPA arrangement, between Hong Kong and the Mainland ever since, there is an urgent need for better understanding of the Chinese legal system and its interaction with the common law in Hong Kong. Accordingly, current work of the Chinese Law Programme is focused on issues relating to the interface between the legal system of Hong Kong and that of the Mainland.

Website

The Chinese Law Programme's website, Chinese Legal Studies (www.lexchina.com) established in the 2004-2005 academic year has seen substantial development in the 2006-2007 academic year. As a research tool, this website is designed to study Chinese law in a broader cultural context and from a comparative perspective, focusing on the issues specific to Hong Kong in relation to Chinese law and legal system and issues relating to law and disability, law and rural areas, law and gender studies, and law and animals, which are usually underrepresented in many Chinese law websites. By focusing on these issues, this website may emerge as a website having its own unique identity.

Community Service

Mr. Ong Yew-kim, an Honorary Research Fellow long associated with the Chinese Law Programme, who is also an advisor for the Center for Constitutional and Human Rights Research at Shenzhen University and an extramural professor at the China University of Politics and Law, continues to be very active in offering opinions on things relating to Chinese law and the issues pertinent to Chinese as well as Hong Kong laws at the invitation of major TV and Radio stations. He spoke on numerous occasions, addressing Chinese and Hong Kong law issues as they affect daily life of Hong Kong people. Mr. Ong has also been involved in providing legal assistance to Hong Kong citizens involved in Chinese legal system. He continued to assist individuals who were wronged or mistreated by the legal system or personnel of the Mainland in getting justice or compensation. He also was a lecturer on Chinese law for legal training classes organized by local communities.

FUNCTIONAL SERVICES

Documentation Unit

Coordinator: Mr. Simon X.H. Shen

The Documentation Unit (DU) has continued to build up its collections in the past year. 130, 111 and 1,086 items have been added to the Hong Kong Collection, the Asia-Pacific Collection and the Academic Journal Collection respectively. The total number of books, periodicals, and other reference materials has reached approximately 51,000. As in the past years, the DU pursues the strategy of acquiring basic reference materials on one hand and other items of interest that are not generally acquired by major academic and public libraries on the other. Such items included research data, government publications, regular and occasional reports by private and public academic institutions, etc. We are currently more selective in acquiring these items than before as some of them have become available through the internet.

The most distinctive asset of the DU is its collection of Hong Kong newspaper clippings from 1955 to 2000. Functions as a source of information supporting numerous fields of Hong Kong Studies, the collection is one of the longest-running collections of Hong Kong newspaper articles. Since 1998, the DU has initiated a project to convert the 450,000 clippings into an electronic database. With the generous support from the Lee Hysan Foundation Limited in 2005/2006, we were finally able to invite professional data processing companies to handle the project. We have agreed to donate a hardcopy of our clippings to the Zhuhai Campus of Beijing Normal University when the conversion is completed. The project is finished 90% already and is expected to

be completed within 2007. Various initiatives to effectively utilize the scanned documents are under enthusiastic consideration.

The DU's reading room had 52 visitors in the past year, about 10% of them were from outside the Chinese University. The reading room also continues to provide its archival function and services to the Institutes' research programmes and the University.

External Liaison

Coordinator: Prof. Timothy Ka-ying Wong

Prof. Timothy Ka-ying Wong is responsible for external liaison work of the Institute. This is a duty of a rather regular and routine nature. The overall objective is to publicize the activities of the Institute so that the public and concerned groups or persons can be informed of our work, make use of our research results and take part in our activities. External liaison has three main components:

Publicity about our publications includes preparing and issuing press releases to the media, distributing information sheets and order forms to relevant institutions and individuals, and liaising with our distributors.

Publicity about our conferences and seminars includes preparing and issuing press releases, sending invitations and publicity materials to the media, arranging and facilitating the reporting work of the press, and assisting the organizing committees to handle enquiries and public relations.

Liaison with overseas institutions and individuals includes the handling of enquiries and the exchange of information and publications.

During the last year, over 90 scholars from the mainland and overseas have visited the Institute, 11 seminars, forums, conferences and press conferences have been held, and 17 occasional papers and 3 research monographs have been published. On the whole, our guests and visiting participants were pleased, and the coverage of our seminar/conference activities by the media was satisfactory. Our publications were also made known and distributed in an effective manner.

Publications

Coordinator: Ms Wan Po-san

The aim behind the publications of the HKIAPS is to disseminate and promote research on social, economic, and political developments in Hong Kong and the Asia-Pacific region. It is hoped that the extensive and effective dissemination of our research findings will broaden their intellectual and social impact, and allow more donations to be solicited for studies in the applied social sciences.

Scholars both inside and outside the Chinese University are welcome to submit manuscripts for consideration. The manuscripts received are evaluated by the Editorial Committee in collaboration with invited reviewers of relevant specialities. Priority in publication is given to the results of research undertaken by academics affiliated with the Institute and related to the domains of the established strategic research programmes.

Six publication series, namely the Research Monograph Series, Occasional Paper Series, the Shanghai-Hong Kong Development Institute (SHKDI) Research Monograph Series, the SHKDI Occasional Paper Series, the SHKDI Forum Series, and the USC Seminar Series, are regularly produced. The first four series are mostly the results of research undertaken by scholars at the Institute. The SHKDI Forum Series publishes selected papers presented at the annual forums of the SHKDI. The USC Seminar Series publishes selected research papers presented at the seminars of the Universities Service Centre for China Studies. In addition, the Institute publishes the Asian Economic Journal for the East Asian Economic Association.

Telephone Survey Research Laboratory

Coordinator: Prof. Timothy Ka-ying Wong

The Laboratory

Established in May 1995, the Laboratory can handle over 30 telephone lines, all connected to the CATI (Computer Assisted Telephone Interview) system operated through a main server. It can cope with the demands of large samples under time constraint.

Objectives

- To provide a telephone survey laboratory to researchers at the Chinese University who want to use a telephone interview technique to facilitate their research.
- To enable the development of new research interests using the telephone interview method.
- To collect panel public opinion data of academic and social value.
- To serve as a link between the Chinese University and the public by regularly offering results of survey polls on public issues.

Accomplishments

Over 660 commissioned surveys have been completed since the establishment of the Laboratory (47 surveys in the past year).

Our survey findings have been widely covered by the media, thereby helping to raise the profile of the Institute and the Chinese University.

The Laboratory has attracted an increasing number of researchers from academic circles and the media who want to use telephone survey as an alternative method of data collection.

With the improving financial situation, we have designed and launched our panel surveys for academic research. We have trained and pooled over 70 experienced interviewers from amongst CUHK students as well as students from other universities, providing them with not only a good source of income but also the valuable experience of conducting telephone survey research.

We have conducted several seminars for secondary school and technical college students and introduced them to the methodology and interpretation of opinion polling.

Policy

The Laboratory welcomes the sponsorship or commission of surveys; it is also open to collaboration with interested persons or organizations.
