New Prestigious Book Published by Prof. Zhan Jing Vivian in Cambridge University Press - China's Contained Resource Curse



Book Information:

This is the first monograph on the socioeconomic and political impacts of minerals on contemporary China. This book takes a novel perspective on the resource curse by disaggregating the society into three key actors, the state, capital, and labor. It tells nuanced stories about the distinctive effects of mineral resources on the state-capital-labor triad in China, a resource-rich country that has been largely overlooked in the resource curse discourse. Taking a subnational approach, this research zooms in on local situations and identifies clear causal channels through which mineral resources affect local development and governance as well as the welfare of local citizens. Characterizing mining industries as pro-capital and anti-labor, this research also highlights the redistributive roles that the state can play to address the unfair game. It reveals the Chinese state's strategies to contain the resource curse and also pinpoints some pitfalls of the China model, which offer important policy implications for China and other resource-rich countries.



Author Information:

Dr. Zhan specializes in comparative political economy, contemporary Chinese politics, intergovernmental relations, local governance, and development studies. Her pioneering research on China's resource sector and resource policies has been published in journals such as the China Quarterly, Environmental and Resource Economics, and the Extractive Industries and Society and received the CUHK Research Excellence Award.

Hui Li, Shui-Yan Tang & Carlos Wing-Hung Lo (2022): Resource dependency, perceived political environment, and ENGO advocacy under authoritarian rule, *Journal of Environmental Policy & Planning*, DOI: 10.1080/1523908X.2022.2031928

Abstract

ENGOS are an essential part of the institutional fabric of environmental governance. A key issue is how they participate in environmental policymaking through different strategies, including legal, administrative, and media advocacy. Using original data on Chinese ENGOS, this article examines how ENGOS' dependency on government funding and donations, and their perceptions of the broader political environment, affect their engagement in policy advocacy. Our empirical analysis shows that a) government funding increases ENGOS' engagement in all advocacy strategies, whereas donations reduce administrative advocacy; and b) the perceived political environment affects ENGO advocacy strategies by changing the dynamics between funders and ENGOS, triggering caution against political risks and increasing ENGOS' dependence on donors. This study highlights how a restrictive political environment shapes ENGOS' relations with the state and their philanthropic donors in environmental governance.

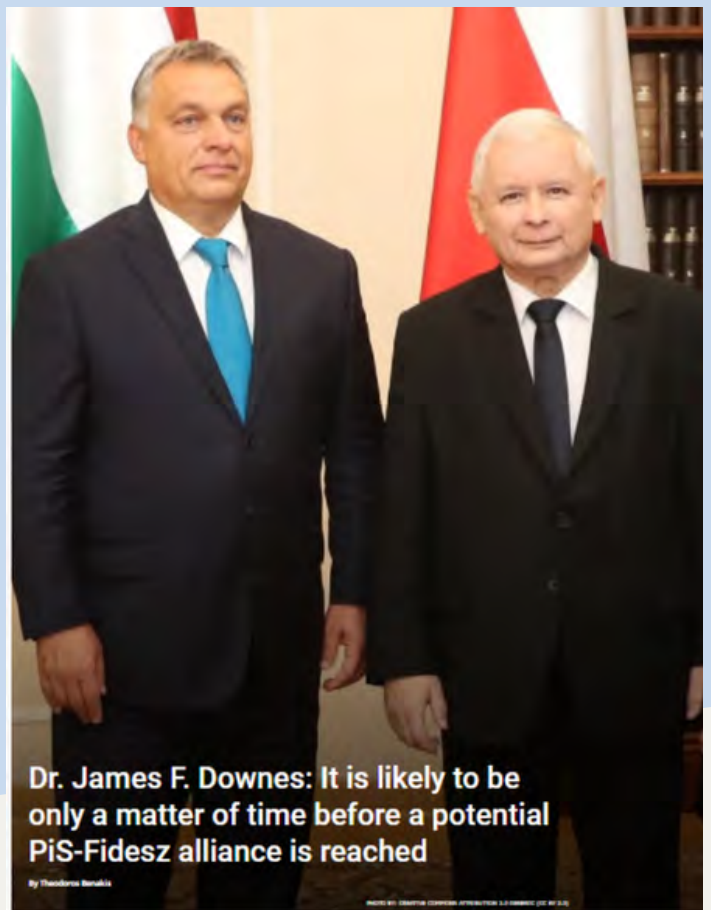

Interview on European Populism for a Brussels Based Newspaper by Dr. James F. Downes

Brussels-based newspaper European Interest had the opportunity to interview Dr. James F. Downes on the rise, governing and expected future politics of the two government parties.

Dr. Downes explained how the two governments move towards the radical right and their “bras de fer” with the European Commission and the European Parliament. He also discussed the potential of an alliance between the two parties and governments.

“Based on current events within both the PiS and Fidesz Governments, that it is only likely to be a matter of time, before a potential PiS-Fidesz alliance is reached, either via a formal EU Parliament bloc (with other political parties such as The League in Italy) or via an informal domestic level pact/alliance between both Fidesz and PiS”, argues Dr. James F. Downes.

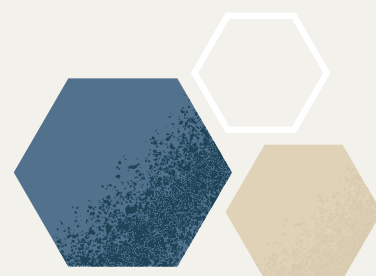
Postgraduate Student Update

We are very pleased to announce that our former PhD Student and recent graduate Dr. Felix Wiebrecht has received a Post-Doctoral offer from the prestigious Varieties of Democracy Institute (V-Dem) at the University of Gothenburg, based in Sweden.

The V-Dem Institute, led by Professor Staffan I. Lindberg is an independent and internationally renowned research institute. The Headquarters of the V-Dem project houses one of the worlds largest-ever social science data collection projects with over 3000 researchers and other experts from 180 countries.

Most significantly, their dataset includes more than 450 specific indicators, over 50 different indices of democracy and human rights, alongside civil society, legal system and 27 million data points from 202 countries covering the period between 1789–2018.

Many congratulations to Felix on such a fantastic and well deserved achievement!





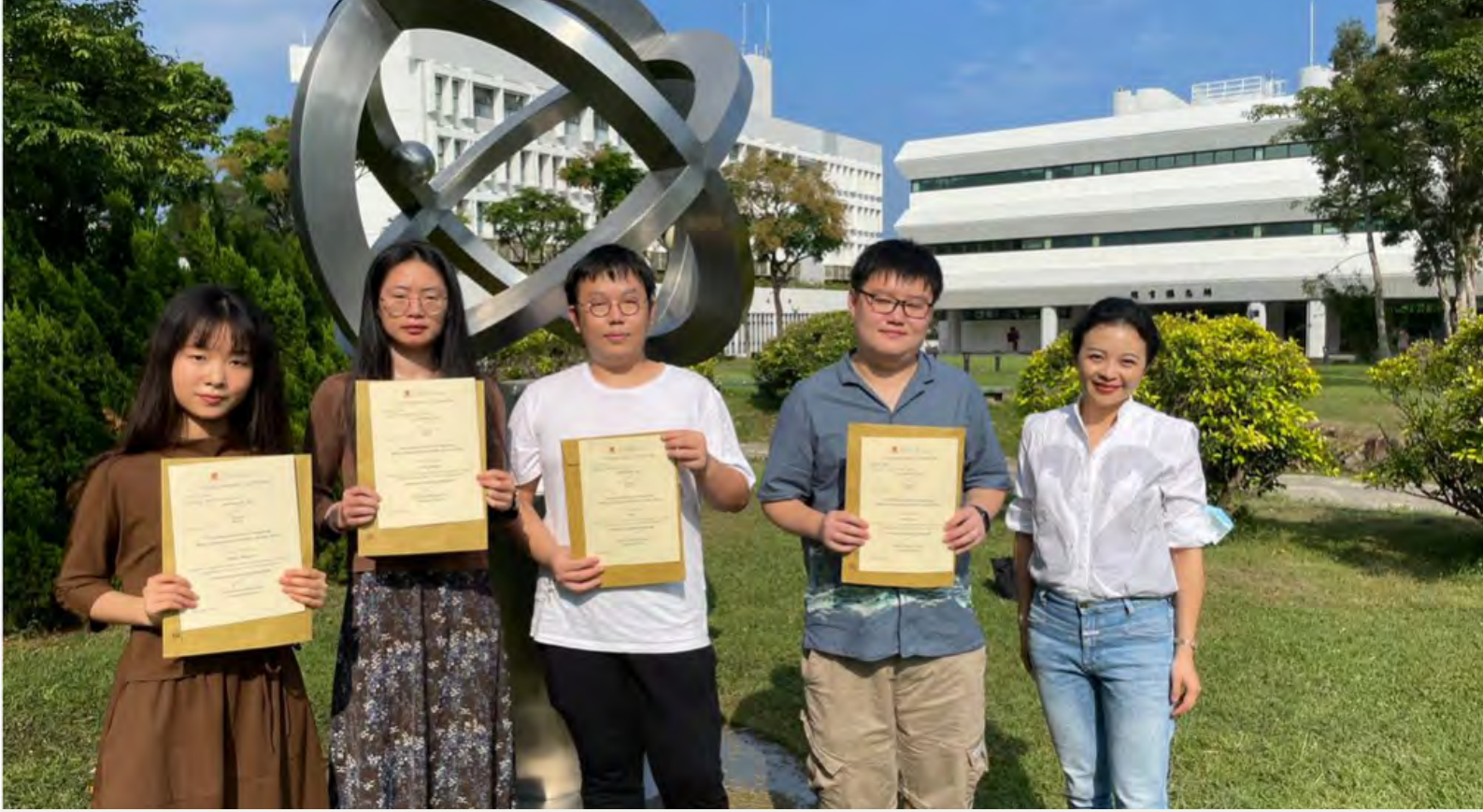

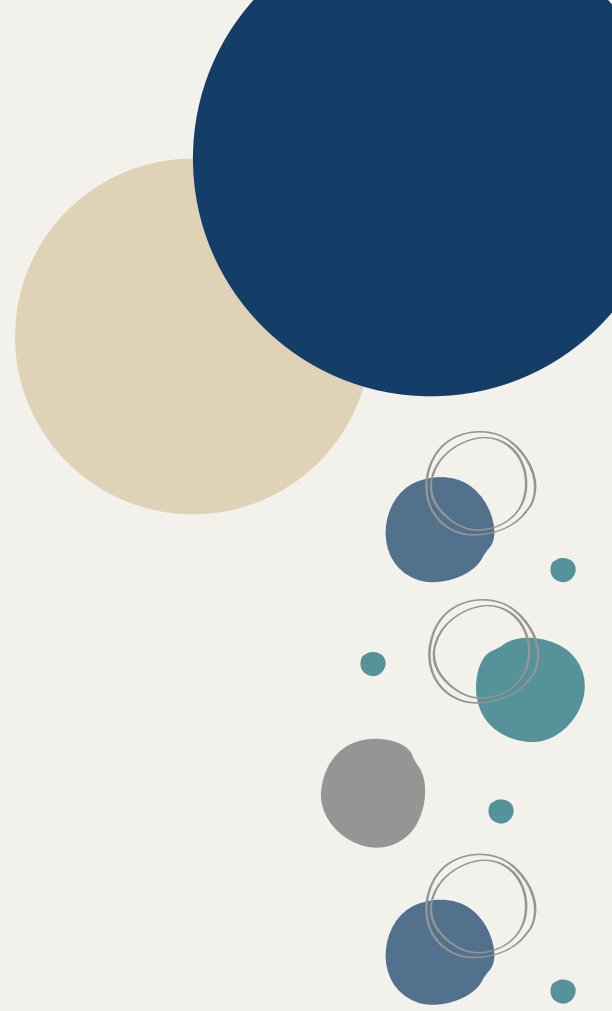

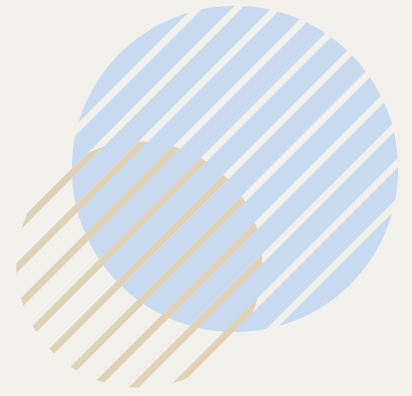
Master Programme Updates
