- Postgraduate degree in life sciences or engineering, business and related qualifications is an advantage
- Familiarity of R&D corporate affairs and operations for technology companies

- Knowledge of latest technology development trends in engineering, healthcare, and biotechnology
- Knowledge of start-up and funding environment in Hong Kong, GBA, China, USA, Europe an advantage
