1. Developing Year 5 Ethical issues in Everyday Family Practice during the module of Community and Family Medicine 2019 onward

2. Leader of new Top up B.Sc Degree programme in Community Health Practice funded by block grant (starting in 2013)

The global triple burden of health: epidemics of non-communicable diseases, reemergence of communicable diseases and mental health calls an urgent need to have another level of health practitioners bridging between the highly skilled professionals (doctors, nurses, other allied health professionals) and auxiliary staff (health care assistants). The society needs a group of health practitioners with sound mind and knowledge on general health issues to care patients in community for early intervention of risk factors and intensive care co-ordination to minmise hospital admission as far as possible. Graduates of this two-year full-time top up Bachelor of Science would meet the emerging needs of contemporary society. My experience in developing community services by translating medical knowledge to public education in empowering the community to advocate for policies changes meeting their needs has helped the junior academic staff in developing and delivering this new programme.

3. Train the Trainer for medical education in Family Medicine

Despite extensive evidence showing the cost effectiveness of primary health care and the significant role of family physicians, the development of family medicine in Hong Kong has not advanced at the same wavelength as other developed countries. Not only we are short of academics in family medicine, there is also problem of translation of knowledge into real clinical setting because of dual health care system in Hong Kong. With my background experience in different types of family medicine practices (public ad private, solo and group) and involvement in development of vocational training and assessment in family medicine, I have adopted the 'train the trainer' approach in both public and private sectors to strengthen medical education in family medicine with limited resources during early years.

By providing clinical supervision and training for FM residents in public setting, not only train up a substantial pool of young doctors as qualified family physicians and also expand teaching sites to different FM clinics territory wide with many of my former trainees now taking up senior positions in different FM clinics in HK. One cannot ignore the education opportunities in private sector as it accounts for 70% of primary medical care. I make use of the CUHK Diploma in Family Medicine (DFM) upgraded to Master (MFM) in 2003 as enrichment programme for primary care physicians in practice without formal FM training. Substantial numbers have later obtained higher professional qualifications. This approach has made use the double edges of the sward to enable quality assurance of medical education in FM meeting the standard as well as the needs of community

The success of the programme has inspired our colleagues in Macao and Mainland China to invite us to provide structured training and continuing professional development for their primary care physicians. Currently both MFM and DFM are quotable qualifications by Hong Kong Medical Council. Holders of DFM would be considered for exemption for Monash University MFM and vice versa I have edited two textbooks in family medicine and contribute 18 chapters for textbooks related to family medicine and primary care. I have contributed cases for both undergraduate and postgraduate examinations in family medicine and act as external examiner for other universities as well as examiner for Conjoint Fellowship examination of both

Hong Kong and Australian academic colleges.

4. Clinical teaching in Family Medicine

I participated in senior management of clinical services in primary care to develop better clinical teaching facilities for students. In 1999, I was appointed as Honorary Consultant in Family Medicine of Kwong Wah Hospital with over 1,000 beds and one of the oldest public General Out-patient Departments in Hong Kong with attendance over 600 patients daily but the design was very primitive mainly for episodic care. My task was to upgrade the Medical centre as recognized training centre in family medicine so the patients would receive comprehensive and holistic care. I trained the Head of the department to become specialist in family medicine and worked along with her to supervise the new residents and professional development programme for the older generation of doctors to upgrade their skills. The Centre is now well equipped for teaching and training family medicine at both undergraduate and postgraduate level.

In 2004, I was appointed to become the Consultant i/c of Lek Yuen Health Cente of similar scale and past history. The job required the Consultant in charge transferring his clinical skills to the juniors to evolve a team of experienced specialist residents in case management and some later became associate consultants/consultants. Some of them are our own alumni and a new generation of well qualified teachers in family medicine is now in place.

5. Development of Health Education and Health Promotion postgraduate programmes meeting the needs of different sector

I first started a Professional Diploma programme then upgraded to Master degree programme and graduates include leaders of different sectors such as Head of Nursing services at Department of Health, President of Hospital Pharmacists Association, school principals, education officers/lecturers, and some graduates are now pursuing doctoral study. Some of the modules have been used for leadership training for HealthPromotingSchools and Health Promotion in general at international level, e.g., WHO, overseas academic institutions and professional bodies. The modules have also been used to develop a structured training programme for school health professionals in Macao.

6. Development of inter-disciplinary Primary Health Care Programme

With support of a grant from Professional Services Development Assistance Scheme (operated by Trade and Industry Bureau of Hong Kong SAR Government), I developed first of its kind a professional diploma programme for multi-disciplinary

education on Primary Health Care for health care professionals. The ultimate aim was to enhance the development of an integrated primary health care system with trans-disciplinary approach. The skills of primary care practitioners can be enhanced as case managers in primary health care. A Professional Association for Primary Care Practitioners was established. Two conferences were organised resulting a special journal issue on primary care.

7. Development of new Senior Secondary School Subject: Health Management and Social Care (HMSC)

The aim of curriculum is to nurture students as reflective, responsible and caring citizens who will be able to:

- lead and promote a healthy lifestyle for the well-being of the communities and society
- analyze and evaluate actions / strategies of health and social care issues from different perspectives
- work out constructive solutions for health and social care issues

I served as Chairman of HMSC Committee since inauguration in 2004 and haven instrumental in curriculum framework, design of assessment, professional development for teachers, development of learning resources and enrichment courses. I have also been leading the team to brief key stakeholders about this course including academic institutions, health and social care sectors, parents, education leaders and schools managers. We now have students entering different university programmes including, medicine, nursing, social work, education, public health.
