

創傷的修復與療癒:解雞剛傷

本工作坊將以穩定和啟動受創者的內在資源(stabilizing and resourcing)為基礎,探討在療癒創傷記憶階段的原則及注意事項。此外,會透過結構性解離理論以及實務案例,幫助參加者了解結構性解離的本質。

工作坊亦會透過部分工作(parts work)的相關理論和技巧,如自我狀態理論(Ego State Theory)和內在家庭系統治療(Internal Family System),協助學員認識如何處理案主的創傷記憶、解離部分,及解離所產生的困難(如自我傷害或飲食困難)。學員會透過實務案例和互動的方式去體驗部分工作的相關技巧。



講者: 盧德賢博士

盧德賢博士於美國先後取得心理學碩士、神學碩士及臨床心理學哲學博士,並於美國希望城國家醫學中心及貝克曼研究所參與腦神經心理學博士後進修。曾於美國多間醫院包括 UCLA 附屬醫院及退伍軍人醫院實習並擔任研究職務,為美國加州註冊臨床心理學家、EMDR 認證治療師(EMDRIA CERTIFIED THERAPIST)及IFS (L2) 受訓治療師。盧博士也是香港心理學會註冊臨床心理學家及香港專業輔導協會認可輔導督導,對情緒管理、創傷治療、眼動減敏重整治療、靜觀治療有豐富的臨床經驗。
