#### **HSBC Overseas Scholarship Programme 2019/20**

#### Information Sheet

HSBC is inviting applications for scholarships which support non-final-year full-time undergraduate students to study in an overseas university for **either one semester or one academic year** in the academic year 2019/20. The maximum amount of each scholarship for the academic year 2019/20 is HK\$300,000.

#### The Scholarship

The scholarship will enable students who are currently studying under any one of the following disciplines funded by the University Grants Committee to spend a semester or an academic year **AS A VISITING STUDENT** or **AN EXCHANGE STUDENT** at one of the overseas universities listed in Attachment A.

All disciplines under architecture, business and economics, communication, computer science/information systems, construction and land use, dentistry, design, education, engineering, health care, hotel and tourism, law, medicine, science (basic and applied), social sciences, humanities, textiles, arts subjects (linguistics and languages, translation, history, geography, fine arts and applied arts etc), energy and environment, Asian and International Studies, and creative media.

To enable students to have more exposure in their fields of study, students will have the flexibility to major in a different discipline other than the one the student is currently studying while abroad. The discipline, however, will have to be listed in the approved courses listed above.

Students are required to participate in and complete the Hong Kong Young Ambassador Scheme (HKYAS). Please refer to <a href="http://yas.hkfyg.org.hk">http://yas.hkfyg.org.hk</a> for more information about HKYAS. Students may participate in other similar programmes with prior written approval from HSBC.

Students should undertake to abide by the policies and requirements of both The Chinese University of Hong Kong (CUHK) and overseas universities, and to participate actively in campus life and the community while overseas.

Conditional offers will be made in April 2019 to candidates who fulfil all the selection criteria, and are recommended by CUHK and selected by HSBC interview panel. Offers will be confirmed upon receipt of the following documents:

- (1) the official admission letter from the overseas university;
- (2) an application to HKYAS or similar programmes approved by HSBC in writing;
- (3) a letter from the overseas university outlining the duration of the academic year and information on the number of credits/courses that a visiting or full-time overseas student should take; and
- (4) a completed pro-forma summary sheet on the cost breakdown authenticated by the Office of Admissions and Financial Aid of CUHK. Please note that the information on credits to be taken overseas and the costs submitted should be regarded as final. Costs of any additional credits taken during the academic year abroad will not be covered.

HSBC and CUHK do not have any arrangements with the overseas universities designated by HSBC (please refer to Attachment A for the List of Overseas Universities) whereby scholars will be guaranteed admission. Selected candidates are responsible for fulfilling all application procedures and admission requirements at overseas universities of their choice from the List of Overseas Universities (Attachment A) and be offered a place subsequently. Candidates are, therefore, strongly advised to pay the closest attention to application procedures as soon as possible and selected candidates should secure acceptance independent of HSBC and CUHK.

#### Value of the Scholarship

Under the recommendation by CUHK at the time of nomination, a maximum total value of each scholarship is HK\$300,000.

Scholarship amount for each scholar can only go towards (1) tuition fees and mandatory college fees, (2) a minimum economy return airfare, (3) reasonable room and board costs, books, a small portion of living expenses and visa application fees. The scholarship amount does NOT cover insurance, clothing expenses and other incidentals. Please refer to Attachment D for the "Guidelines on How to Calculate an Overseas Scholarship Award Amount" provided by HSBC for details.

#### **Eligibility**

The applicants must be:

- registered CUHK students in the tenure year of the scholarship;
- non-final-year full-time undergraduate students;
- currently studying under a discipline funded by the University Grants Committee;
- Hong Kong permanent residents with the right of abode in Hong Kong;
- with a minimum cumulative GPA (i.e. CGPA) score of 3.7 (top 3% of class/department, or equivalent) in the first term of academic year 2018/19;
- well-rounded, participating in extra-curricular and community service activities;
- no extensive experience of living or studying overseas;
- preference will be given to eligible students from disadvantaged backgrounds;
- committed to Hong Kong; and
- with a minimum total TOEFL score of 90 (Internet-based test) with scores for individual sections not lower than 22 on listening, 17 on writing, 21 on reading, and 21 on speaking; **OR** a minimum IELTS overall band score of 6.5, with no component below 6.0. These are irrespective of the admission requirements of the intended overseas universities. Test must be taken **on or after 19 February 2017**.

#### **Application Procedures**

- 1. Application form is obtainable from the website of the Office of Admissions and Financial Aid at <a href="http://admission.cuhk.edu.hk/">http://admission.cuhk.edu.hk/</a> (Financing Your Studies → Scholarships → Open for Applications).
- 2. Completed application form together with all requisite documents (please refer to the "Checklist of Supporting Documents" for details) should be submitted **IN PERSON** to the Scholarships and Financial Aid Section, Office of Admissions and Financial Aid, Room 1202, 12/F, Yasumoto International Academic Park during office hours (Monday Friday 8:45 a.m. 1:00 p.m. and 2:00 p.m. 5:30 p.m. except Public Holidays) on or before 27 December 2018. Late or incomplete applications will not be processed.
- 3. Suitable candidates are required to attend a selection interview held in and by the University in late January 2019. Shortlisted candidates are then required to attend a HSBC panel interview in person in Hong Kong in March 2019. No phone interview/ interview by skype will be arranged. The cost of travel to the interviews will not be reimbursed to the candidates.
- 4. Though the academic results for Term 1 of 2018/19 is not available yet, interested students should still submit their scholarship applications if they would like to be considered. However, only applicants who have eventually attained a CGPA (up to first term of 2018/19) of 3.7 (top 3% of class/department, or equivalent) will be shortlisted for further selection.
- 5. Applicants are strongly advised to sit for the TOEFL or IELTS Test by the end of 2018 in order to fit in the application schedule of this Scholarship Scheme. Delayed provision of TOEFL or IELTS Test score transcript will result in partial submission of his/her application, and his/her application will therefore not be processed.

## ☆ Value of the Scholarship



## **☆ Eligibility**

The applicants must be:

- Hong Kong permanent residents with the right of abode in Hong Kong;
- non-final-year full-time undergraduate students;
- with a minimum cumulative GPA score of 3.7 (top 3% of class, or equivalent); and
- with a minimum total TOEFL score of 90 (Internet-based test) OR a minimum IELTS overall band score of 6.5. Test must be taken on or after 19 February 2017.
