#### Parking Label for Resident Postgraduate

- (1) Resident postgraduate who is in possession of a valid driving license and ownership of vehicle may apply for parking label charged on term basis.
- (2) Paid label fee is non-refundable. Whenever the label holder ceases to be a resident on campus, the label should be returned to the Security Office for cancellation.
- (3) Parking label is charged at \$1,000 for each six-month cycle.
- (4) Overnight parking is permitted in the area of hostel.

#### Notes for label holders:

- The six-month cycle for all paid labels starts either in October or April each year.
- Replacement for lost or damaged label will be charged at renewal rate.
