## Preamble 前言

Under the school-based management (SBM) spirit, aided schools are given more autonomy and greater funding flexibility to manage the operation and resources of the schools for the provision of quality education. In return, schools are expected to be more transparent and accountable for their operation and key stakeholders should be involved in the decision-making process. As members of the incorporated management committees (IMCs), school managers play an important role in leading and steering the school for continuous development and improvement, as well as providing an all-round education for students. This Programme B is designed to help serving or potential managers of aided schools, who are quite familiar with education and school operation or have completed Programme A, perform their roles more effectively under the SBM governance framework as stipulated in the Education Ordinance.

在校本管理精神下,資助學校在運作上享有更大自主權,亦可靈活運用資源,以給予學生優質教育。與此同時,學校須增加透明度,加強問責機制,並容許主要持分者參與校政決策。身為法團校董會成員,校董須帶領學校持續發展和改進,並推動學生全人發展,角色至為重要。本課程旨在協助熟悉教育及資助學校運作,或已完成課程甲的現任或擬任校董,了解按《教育條例》訂明的校本管理管治架構,有效履行其校董職責。

# Programme Objectives 課程目標

The aims of the programme are: (i) to enable participants to be more confident of leading the school from strength to strength under the spirit of SBM; (ii) to broaden participants' perspectives in assuming strategic leadership to take forward school development and understanding legal matters related to school governance so as to equip them to be more effective school managers.

本課程旨在:(i) 加強學員領導學校的信心,以落實校本管理的精神;(ii) 擴闊學員眼界,使他們成為學校發展的策略性領袖及了解學校管治的法律議題,提升其校董角色的效能。

#### Programme Content 課程內容

The programme consists of two parts, namely Part 1 "School Governance" and Part 2 "Legal Matters". For Part 1, each course lasts for 9 hours in total and comprises 3 modules in 3 sessions. For Parts 2A and 2B, each course lasts for 6 hours in total and comprises 2 modules in 2 sessions. An online manager learning programme comprising 3 parts (i) essence of school-based management; (ii) legal matters related to school governance; and (iii) school policy and development is provided as fundamental learning activity.
