2022 至 2023 年度學生宿舍申請須知 Note to Applicants for Student Hostel Residence (2022-23) (本地新生適用) (For Local Freshmen)



書院會使用透過宿舍申請所獲得的個人資料作處理宿舍申請用途。申請人有權透過電郵 (polly@cuhk.edu.hk) 索閱及修正個人資料。提供個人資料純屬自願性質。
Any personal data collected by means of the hostel application will be used by Wu Yee Sun College for the purpose of processing hostel application. Applicants have a right of access and correction with respect to personal data as provided for via email to polly@cuhk.edu.hk. The provision of any personal data is on a voluntary basis.

The arrangement of student hostel residence is subject to the development of COVID-19. The College reserves the right to make any appropriate amendment, including but not limited to amending the hostel period or delaying the check-in date. Students allotted a hostel place should pay attention to mass emails for announcement. 書院或因應新冠肺炎之發展更改學生宿舍之安排(包括但不限於更改宿期、延遲入宿日)。獲分配宿位之同學請密切留意書院經電郵發

- 1. 書院宿舍提供604個宿位予本院學生申請·全為雙人房·惟因應新冠肺炎疫情或改為單人入住。視乎疫情發展·實際可提供宿位數目及房間分配安排可能大幅更改·宿位分配準則將因應大學/書院政策作出相應改動。
 - 604 hostel places at the College hostels are available for students of the College. All are double rooms but may be changed to single occupancy due to COVID-19 pandemic). Subject to the newest development of the pandemic, there may be a substantial change of the actual number of available hostel places and room assignment. The rationale of hostel allotment will be adjusted in accordance to the latest University/College policy.
- 2. 鑑於政府 2022 年 2 月 24 日起實施「疫苗通行證」(https://www.coronavirus.gov.hk/chi/vaccine-pass.html) · 所有以「中大通」進入校園的學生應把最新的疫苗接種紀錄或醫學豁免證明書上載至疫苗接種紀錄 / 定期病毒檢測申報系統。基於醫學原因無法接種疫苗的學生則必須每星期進行一次定期自我檢測及遞交網上申報表。申請人需按照「疫苗通行證」要求於指定時間完成接種所需劑量·並提供認可疫苗接種紀錄,顯示疫苗種類被包括在政府的新冠病毒專題網站「就指明用途認可 2019 冠狀病毒病疫苗列表」上

(https://www.coronavirus.gov.hk/pdf/list of recognised covid19 vaccines.pdf) 及已完成接種所需劑量;或提供有效醫學豁免證明書。如屬新冠肺炎康復者而獲豁免接種·請提供康復或感染證明(例如出院文件、衞生署發出的隔離令)·單憑快速抗原測試陽性結果的相片並不能作為有效的康復紀錄。

As the government has launched a "Vaccine Pass" (https://www.coronavirus.gov.hk/eng/vaccine-pass.htm) with effect from 24 February 2022, students accessing campus via CU Link cards are reminded to upload their most updated vaccination records or proof of medical exemption to the VTR portal. For students who are unable to receive vaccination for medical reasons, regular self-testing for online reporting at least once every week is required. Applicants must receive all required dosage within designated schedule according to "Vaccine Pass", and provide recognized vaccination record on which the vaccine is on the list of recognized vaccines on the Government's COVID-19 Thematic Website (https://www.coronavirus.gov.hk/pdf/list of recognised covid19 vaccines.pdf) and received all required dosage; or provide valid proof of medical exemption. For persons recovered from COVID-19 eligible for exemption, please also provide proof of recovery/infection (e.g. discharge documents, isolation order issued by Department of Health). Photograph showing a positive rapid antigen test result alone cannot serve as a valid recovery record.

- 3. 2022 至 2023 年度之宿期由 2022 年 9 月至 2023 年 5 月。農曆新年期間宿舍會關閉數天,宿生如欲留宿需另行申請。暑期宿舍安排及申請將另行通告。
 - The residential term for 2022-23 is from September 2022 to May 2023. The hostel will be closed for a few days during Lunar New Year. Residents are not allowed to stay at the hostel unless otherwise requested and approved. Summer residence arrangement and application will be announced in due course.
- 4. 2022 至 2023 年度之宿費為港幣 14,182 元。另宿生須繳付宿生會費港幣 30 元及宿舍鎖匙按金港幣 1,000 元。 The annual hostel fee for 2022-23 is HK\$14,182. All residents are also required to pay a Resident Association fee of HK\$30 and a refundable deposit of HK\$1,000.
- 5. 申請人須於 2022 年 8 月 25 日中午 12 時至 8 月 28 日中午 12 時於網上 (https://cloud.itsc.cuhk.edu.hk/webform/view.php?id=13652819; 需以學生編號登入)輸入申請資料*·簽署由系統自動寄出之電郵確認書·然後按<u>附件三</u>之指示於截止申請日期或之前上載證明文件至指定 OneDrive 雲端連結 (宿舍申請證明文件)。若書院於截止申請日期後未能於雲端找到必須之證明文件·一律當作欠交處理。逾期或資料不足之申請概不受理。
 - *若申請人從香港以外地區返港·必須另行填妥入宿前旅遊紀錄 (https://cloud.itsc.cuhk.edu.hk/webform/view.php?id=13648280)及上載相關證明文件至指定 OneDrive 雲端連結(外遊紀錄)。

Applicants must first submit their online application* ((https://cloud.itsc.cuhk.edu.hk/webform/view.php?id=13652819); login with student ID needed) from 12:00 noon, 25 August to 12:00 noon, 28 August 2022. Sign the notification which is automatically sent to the email address provided by the applicants. All supporting document(s) must be uploaded to the designated OneDrive URL (supporting documents for hostel application) according to the instructions in Appendix 3 by the application deadline. If any necessary supporting document cannot be retrieved from the OneDrive space, such document will be considered missing. Late or incomplete applications will NOT be handled.

*Applicants returning from <u>outside Hong Kong</u> must also complete an online form for travel history before hostel check-in (https://cloud.itsc.cuhk.edu.hk/webform/view.php?id=13648280) and upload relevant proofs to designated OneDrive URL (Travel History).

6. 宿生遴選之基本準則為總車程時間及人均居住面積,計分方法請參看附件一。
Resident selection is mainly based on the total travelling time and living area per capita. Please see Appendix 1 for the scoring scheme.

- 7. 書院設有「四年一宿」制度。本院畢業班同學若未嘗於校內學生宿舍住宿(暑期宿舍除外),可獲優先分配宿位;常規修業期為三年或以下之同學,可獲保證有一學期宿位、常規修業期為四年或以上之同學,則可獲保證有一學年宿位(不包括暑期課程學期)。非畢業班而從未曾獲派學期宿位(暑宿除外)之同學,亦可於網上表格選擇行使其「四年一宿」權,若其未能根據宿分獲分配宿位,則可以「四年一宿」再獲入宿機會。但曾於學期間入住宿舍(包括於學期間中途退宿)或曾透過「四年一宿」獲派宿位而放棄(包括入宿前放棄)者,均不得於網上表格選擇行使其「四年一宿」權,如有違反,其2022-23學年宿舍申請資格將被取消。本學年以「四年一宿」分配予非畢業班同學之宿位配額需視乎疫情發展而定,若申請數目多於屆時之配額,則以隨機抽籤決定。
 - "Guaranteed Residence Scheme" is implemented at Wu Yee Sun College. <u>Graduating students</u> of the College who have never resided at student hostels on campus (except for Summer Hostel) will be prioritized in hostel place allocation. Guaranteed residence period for those whose normative study period is 3 years or below is one semester, and that for those whose normative study period is 4 years or above is one academic year (excluding summer term). <u>Non-graduating students</u> who have never been allotted term-time hostel place (except Summer Hostel) can also indicate their choice of exercising this right in the online application. They will have another chance of hostel allocation with the "Guaranteed Residence Scheme" if they cannot be allotted hostel places according to their hostel scores. **Applicants who have resided at the College hostel during term time, or withdrawn from hostel during term-time, or given up their hostel place allotted through "Guaranteed Residence Scheme" (even before hostel check-in) are <u>NOT</u> allowed to make such indication in the online application. Otherwise, they will be regarded as disqualified in the 2022-23 College hostel application. The quota for non-graduating students in this scheme is subject to the newest development of the pandemic. If the number of applications exceeds the quota, random lots will be drawn.**

Applicants who do not live with parents should provide detailed explanation in writing and attach supporting documents.

All resident students, regardless of their vaccination status, have to undertake all College preventive and control measures against COVID-19, including but not limited to non-residents are not allowed to enter the hostels or stay overnight. Residents are only allowed to access their respective hostel floors. Violations will result in disciplinary actions. Residents should check out government website (https://www.coronavirus.gov.hk/eng/inbound-travel-faq.html) and College mass email for the latest information.

 Information submitted by the applicants must be true to the best of their knowledge. A strict assessment of all information provided will be carried out. The College will continue relevant verification work after move-in and reserves the right to demand the original copy of relevant
 - carried out. The College will continue relevant verification work after move-in and reserves the right to demand the original copy of relevant documents for verification. To protect personal data privacy, applicant may redact unrelated personal information on submitted documents (e.g. some digits of personal identification document number, mobile phone number). Any change of information should be reported in writing to the College and the Wardens. False report or forged documents, if found, will result in immediate deprivation of residents' right of residence. The case will also be referred to the College Student Counselling and Disciplinary Committee for consideration of further actions. Applicants' future application for hostel places will not be considered.

The resident list will be announced on the College Website (www.wys.cuhk.edu.hk/downloads.php) on 31 August 20221 tentatively. Student Hostels Committee has the final decision on hostel room assignment.

14. 獲派宿位之同學可於2022年8月31日至9月1日中午12時提交宿舍區域及選擇房伴網上申請 (https://cloud.itsc.cuhk.edu.hk/webform/view.php?id=13653763)·**欲申請同房之兩位學生均須遞交申請,方獲配對**。成功遞交申請後 將有電郵通知·請申請人保留該電郵;如有需要·申請人需向書院提供電郵列印以作證明。書院將盡量根據申請人的偏好作出安排· 並保留房伴安排之最終決定權。凡未按上述方法選擇房伴者·將由電腦隨機編配。房間分配結果暫定於2022年9月2日公佈。

Successful applicants may submit the online application of hostel zone preference and roommate arrangement (https://cloud.itsc.cuhk.edu.hk/webform/view.php?id=13653763) between 31 August and 12:00nn, 1 September 2022. A matching will be considered only if BOTH residents of a room submit the application. Upon successful submission of application, an email notification will

be sent. Applicants should keep the email and present the email printout to the College as supporting document upon request. The College will try to meet applicants' preference as far as applicable and has the final right in the matter of roommate arrangements. For students who fail to do the above, their roommates will be selected by computer draws. Room assignment will be announced on 2 September 2022 tentatively.

All supporting document(s) must be uploaded to the designated OneDrive URL according to the instructions in Appendix 3 by the application deadline. Results of appeals and waiting list will be announced on the College website on 27 September 2022 tentatively.

16. 獲分配宿位者不得轉讓宿位予他人。如欲放棄宿位,必須向書院及舍監提出書面申請,其宿位將按後補名單分配。入宿後欲提早退宿者需於擬定退宿日期前最少 7 個工作天提出申請,退宿申請如獲批准,於扣除一個月之宿費後,同學可按比例獲發還部份宿費。如於2022 年 11 月 1 日或 2023 年 3 月 1 日後申請提早退宿,則須繳交自入宿起計至該學期完結之宿費。

Allotted hostel places are not transferable. Applicants who wish to give up their places must apply to the College and the Warden in writing. Vacant places will be filled up by applicants on the waiting list. Applications for early hostel withdrawal during term-time must be submitted at least 7 working days in advance of the planned last date of stay. Should the application be approved, partial hostel fee will be refunded on pro rata basis with the reduction of one month's hostel fee. Residents who withdraw from the hostel after 1 November 2022 in the first term or 1 March 2023 in the second term will be required to pay the hostel fee counting from the move-in date to end of the relevant term.

Once check-in procedure is completed, despite early withdrawal, students are considered taken one semester of hostel residence.




