ECON 8006: Thesis Research 2022-23 Term 2 (Tuesday 3:30pm – 6:15pm ELB 204)

The main purpose of this course is to equip students with some research skills and experience. The course will first expose students to a wide range of research topics. Guided by the teachers, students will then select a topic for presentation and a short paper. The paper should be a critical comment on a literature or a sub-set of the literature, or a brief empirical analysis of a selected issue.
