TERMS AND CONDITIONS

Part I. Student Agreement to IASP Terms and Conditions

This document sets out the Terms and Conditions for _____
(Student's Name in Full)

in accepting the offer of admission to The Chinese University of Hong Kong (hereafter refer to CUHK) as an exchange/study abroad student where he/she will be given the status of associate student at the University during the study period indicated in the Offer of Admission.

1. The student will comply with all regulations and requirements of the Programme and CUHK, and Hong Kong SAR laws. The student understands that breach of these may cause the termination of his/her studies at CUHK without refund of fees.
2. The student understands that CUHK reserves the right to cancel/alter any part of the Programme or amend the conditions of participation should unforeseen circumstances make it advisable. CUHK shall not be liable for any loss resulting from such cancellation or change.
3. The student understands and agrees that the offer of admission and study at CUHK is contingent upon his/her fulfilment of the prevailing boarding, vaccination, quarantine, and other requirements stipulated by the HKSAR Government and CUHK when he/she enters Hong Kong and studies at CUHK. The requirements may change from time to time as the COVID-19 pandemic evolves. The student is obliged to check and meet the updated requirements at their own expense.
4. The student understands that course prerequisites at CUHK must be met and that course registration is based on availability of offerings and cannot be guaranteed. The student agrees to give his/her consent for the release of grades and provision of CUHK transcript to his/her home institution.
5. The student understands the financial terms and arrangements of the Programme as outlined in the Fees Table, and is aware that CUHK reserves the right to amend the fees as necessary. Fees paid, except hostel deposit, are neither refundable nor transferable under any circumstances.
6. The student understands that he/she should arrange, at his/her cost, accident and health insurance coverage with provisions extended to any costs which may be incurred due to COVID-19, including but not limited to COVID-19 treatment and costs for emergency evacuation/rescuer and repatriation for the duration of his/her studies in Hong Kong. If the student has plans to travel outside Hong Kong, he/she should ensure his/her insurance policy covers those regions as well.
7. The student understands that CUHK cannot guarantee his/her health and safety while on exchange. He/She is responsible for acting prudently and exercising caution and common sense at all times. He/She also understands that he/she may be using different forms of transportation to participate in the exchange programme. He/She agrees that CUHK is not responsible for any personal injury, death, and/or loss or damage to property suffered by him/her during his/her exchange, including periods of travel with, and independent of, the exchange programme.
8. The student will be responsible for all costs arising out of his/her voluntary withdrawal from the Programme prior to its completion, including withdrawal caused by illness or disciplinary action. If the student decides to withdraw from the Programme, he/she understands that the tuition and other fees paid, except hostel deposit, are neither refundable nor transferable.
9. The student realizes that any falsification or distortion in his/her application or subsequent correspondence with Programme authorities will be grounds for the termination of his/her studies at CUHK, together with automatic loss of all fees.
10. The student will authorize his/her home university and CUHK to reproduce and/or release any and all portions of his/her application and related documentation to the Hong Kong Immigration Department for visa application and for purposes relating to his/her study in accordance with the procedures of CUHK.
