

# THE CHINESE UNIVERSITY OF HONG KONG

## Student Residence Bursary Scheme 2022/23

### Guidelines for Applicants

The aim of the Scheme is to provide hostel grant to subsidize partial hostel fee of the needy local undergraduate students who are not able to benefit substantially from the government hostel subsidy.

#### **Eligibility**

To be eligible to apply for the CUHK Student Residence Bursary 2022/23, applicants must:

1. be local full-time undergraduate students;
2. be registered residents of the hostel and have resided in hostel for at least 75% of the time of the term (based on the availability of the hostels for students) ;
3. have average monthly household income (during 1 April 2021 to 31 March 2022) lower than the median of the monthly household income published in the most recent Quarterly Report on General Household Survey by the Census and Statistics Department as follows:

<u>Household Size</u>	<u>Monthly Household Income</u> ^
1 person	\$10,000
2 persons	\$21,300
3 persons	\$35,000
4 persons	\$45,200
5 persons	\$46,900
6 persons or more	\$50,600

4. be not able to benefit from the government hostel subsidy or receive less than \$1,670 per term under the government hostel subsidy.

#### **Important Notes**

1. Students living in single room are not eligible, except with justifiable reasons.
2. Students whose family received Comprehensive Social Security Assistance during the said period are, in general, eligible for the maximum government hostel subsidy\*. Therefore, they need **NOT** submit applications for CUHK Student Residence Bursary.  
\* *Still subject to the individual assessment by the Working Family and Student Financial Assistance Agency*
3. Government hostel subsidy will be automatically considered under the Tertiary Student Finance Scheme (TSFS) application, and therefore no separate application for the government hostel subsidy is required. ## Amount of Bursary

1. For eligible needy students who are not able to benefit from the government hostel subsidy, the value of each bursary will be \$1,670 per term.
2. For eligible needy students who receive less than \$1,670 per term under the government hostel subsidy, the value of each bursary will be the difference between \$1,670 and the approved amount of the government hostel subsidy.
3. The maximum amount of bursary for residents of all types of shared rooms will be the same.

## Application Procedures

### *Submission of Online Application*

1. Eligible students who live in hostel for the first term or the whole year should submit their **online application in Chinese University Student Information System (CUSIS)** (Website: <http://www.cuhk.edu.hk/cusis>; MyCUHK > Click 'CUSIS' icon > Click 'Scholarships and Financial Aid' icon > Select 'Online Application Form' > Public Application > click the magnifying glass to select "Student Residence Bursary") during the application period **from 5 September to 28 October 2022**. For students who live in hostel for the **second term only**, they should submit their applications during the period **from 9 January to 28 February 2023**. **Students who live in hostel for the whole year but submit their applications in the second term will only receive the residence bursary for the second term even if they are eligible.**
2. For students who have applied for University Bursaries and Loans (UBL) 2022/23, the saved data for family income, bank account details and hostel address on the UBL online application form will be automatically shared to the corresponding fields of the Student Residence Bursary Scheme online application form. Students can still make necessary amendments on the data, if any.

### *Submission of Documentary Proofs to College*

3. After submission of the online application, applicants should submit the documentary proofs of monthly income of all members in the family (e.g. salary statement, employer's return of remuneration and pensions, bank account statement indicating salary payments, profit and loss account etc.) for the period from 1 April 2021 to 31 March 2022. **Applicants should print out Section 7 of the online application form and submit together with the supporting documents to their respective College on or before the application deadline.** The application deadline for the first term / whole year residency bursary is 28 October 2022 whereas for the second term is 28 February 2023. **For those who have applied for UBL, they need NOT submit supporting documents to the College.**
4. Incomplete or late applications will not be considered.

28 October 2022	<b>Deadline</b> for submission of applications (including documentary proofs) for 1 <sup>st</sup> term and whole year residence bursary
9 January 2023	<b>Open application</b> for 2 <sup>nd</sup> term residence bursary
28 February 2023	<b>Deadline</b> for submission of applications (including documentary proofs) for 2 <sup>nd</sup> term residence bursary
Late February / early March 2023 #	<b>Result announcement</b> and arrangement for disbursement of 1 <sup>st</sup> term student residence bursary
Late July / early August 2023 #	<b>Result announcement</b> and arrangement for disbursement of 2 <sup>nd</sup> term student residence bursary

# Actual date of result announcement depends on the timing of result announcement of the government hostel subsidy.
